As a Prosecutor, my current caseload is 100% criminal. However, I continue to stay updated on civil laws such as Family Law, Divorce, and Dependency and Neglect.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

As a sole practitioner in a rural community, I adapted very quickly to the pace and particularities of each Court. Being "aware" and possessing the ability to adapt has been a blessing. When I was a legal secretary the attorney I worked for was telling "war stories" of his early days as a lawyer. He looked over at me and said "you have to know how to speak to your clients so they trust you, you have to learn how to speak to the jury so they trust you, and if you don't know when to stop talking and listen to the Judge, nothing you've done up to that point's going to matter!" None of what he said made sense at the time, but as I began trying cases all over East Tennessee, I realized just how valuable his advice turned out to be. Something so basic was the blueprint to structure my practice around. I prepared my clients and ensured they understood the law and what standards the Court would be applying to their case. An informed client, even if the ruling fell short of what was sought, could adapt and move forward in life. It's the ability to "be heard" at every stage and have a vested interest in the outcome of their case. The Courts have always been up front and respectful to me, but I believe a lot of the respect was earned from being prepared the moment I walked into the Courtroom. The same interaction holds true be it in a forum where you may be advocating for change before the Courts at an appellate level,

or simply humanizing your client to an Administrative Law Judge on a review. The Court is quick to gage your intentions and that of your client. As I now have more years behind me practicing and as younger faces enter the Courtrooms, the environment seems to be shifting away from formality, but embracing impatience. The change is concerning, but society as a whole is moving faster and demanding quicker results. Justice should move swift, but it's becoming a very slippery slope.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

My very first jury trial was a first degree murder case in front of Judge Rex Henry Ogle. I was terrified. However, he encouraged me to be a better lawyer, a trial lawyer. It was from his suggestion that I became death penalty qualified. The more knowledge I obtained, the more confident I became in approaching cases. I could make a list of cases by name, include the citation and holding, but what I would note as important would be the learning curve and the implementation of what you ascertained to better serve your client's interests. Understanding how the Court "thinks" was a turning point. When I began my practice, I would check out each court file to review the same. Chancellor Telford Forgety, Jr. would review the files and would make a faint "line" on the pleadings as he reviewed. I quickly discovered that he was outlining the elements contained in the documents before him. By applying what I learned from each Judge and tailoring the same, I became extremely successful for my clients. Those are the areas that are noteworthy. Walking out successful and reaching the best outcome to ensure a child is protected all because you developed a pliable trait that can be adapted based upon observation and preparation.

Fall 1988 I worked for the Sevier County Property Assessor's Office during work study as a Senior at Sevier County High School. I would sneak to the Courtroom and watch the jury trials and motion hearings. I would observe the Judges, and I would watch the people as they left the Courtroom when the decisions were rendered. I was amazed at the faces of the people and the reactions. I want to take the education I have and implement real change and continue Judge Slone's legacy to the bench. I would have cases in his Court, and you could see the immediate change on the faces of people when he rendered his decisions. The defendants and the victims were walking out with closure and hope. Justice is necessary and accountability is a given. Our caseloads are increasing exponentially, individuals are suffering from substance use disorders, and you have the cooccurring mental health issues that need addressed. As Judge, I will hit these issues head on and do so with the community needs placed first.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. *(150 words or less)*

I am seeking appointment as Circuit Court Judge for Part – IV of the 4th Judicial District. The 4th is comprised of Cocke, Grainger, Jefferson, and Sevier Counties. I grew up in Sevier County, lived for a time in Jefferson, my Mammaw's family is from Grainger, and I have lived in Cocke County since 2003. I know the 4th District and the people. We are a proud Community who works hard, cares about our neighbors, and are surrounded by beauty at every turn. As Judge I would ensure that the values of our people would be respected, and I would apply and uphold the law. I genuinely care about the people who come before the Court, but caring for someone also means you must make the hard decisions the law requires – even when it's heartbreaking.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

The answer is yes. I would uphold the law even if I disagreed with the substance of the law. However, there are limits. I take issue with the blind application of a statute that could have constitutional ramifications even though the legislative intent was not to do so. The role of the Judge is broader and carries more responsibilities in weighing the law that may be new and/or novel. Judge Ogle ruled from the bench that a statute was unconstitutional. He stood firm and set out the overreaching aspect of the statute In addressing the example portion of this question, I take issue with the statute of where someone can be charged with having a handgun while being under the influence of alcohol or some other intoxicant. The issue boils down to the possession, or the constructive possession. I simply disagree with the statute, but as a Prosecutor I uphold the law and it is a chargeable offense. I understand the reasoning for the statute, but as written, I take issue with the same. However, I follow the law and as the Judge I would do the
