6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I consider myself to be a general civil litigation attorney. I have also considered myself to be an appellate resource to those who need that service. My practice is a general small community practice. This includes a good deal of domestic litigation, contract litigation, personal injury and occasionally criminal law. I apportion my domestic litigation practice at 75%, my other civil practice at 15% and the remainder of an assortment at 10%. The other civil practice is primarily personal injury, contract disputes and homeowner issues. The assortment that makes up the remainder is landlord/tenant litigation, criminal litigation and construction litigation.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

The entirety of my practice is litigation. It is difficult to place a number on the amount of trials at the trial court level over the course of more than twenty (20) years, as this is a part of my routine practice. I have also had a successful appellate practice and enjoy the research, writing and argument. I have limited experience in Federal Court and administrative bodies, although I currently have an appeal pending before the Commissioner of Commerce and Insurance.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

Somewhat recently, I was able to successfully reverse a trial court ruling that "pierced the corporate veil" holding my Client personally responsible for the liabilities of an LLC in excess of \$250,000.00. Though successes like that are enjoyable, the satisfaction of my job occurs when I know that I have helped put a child in a good position or helped a family out of a difficult situation.

I served as the City Attorney for Coopertown, Tennessee, for approximately seven (7) years. During that time, I was not only litigating on behalf of the City, but became a witness that ultimately led to the Mayor not being removed with an Ouster Petition in Chancery Court. The

note is that the District Attorney in the 19th Judicial District appealed, and I filed a successful Amicus Brief to prevent the State from recovering attorney fees for a frivolous lawsuit from the Citizens of Coopertown, Tennessee.

28. What are your reasons for seeking this position? (150 words or less)

I grew up in Montgomery County, Tennessee. It is home and both my Wife and I have our families there. We attend Church there. I took my family to Robertson County, Tennessee in 1996. It is also home. I have spent half my life in both the counties that make up the 19th Judicial District. I understand the dynamics of both counties and am uniquely qualified to make decisions that reflect the situation in both. They are different. The law does not change between the two (2), but understanding the communities allows me to better assess the facts and apply the law. This position is a way to serve both of the communities that have been such a part of my life and that of my family.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

There are four (4) Circuit Judges in the 19th Judicial District. Of course, there is one (1) Chancellor. The case load for each Judge is immense, especially with domestic cases. This is the reason this position was created. The presiding Judge recently distributed a memorandum that the new Circuit position will be primarily handling domestic relations cases.

My selection would take my primary area of practice and utilize that knowledge to immediately alleviate the back log of cases. I would work to make sure that there is a balance between the counties that gives everyone access to justice.

I will never violate or even curtail the substance of the law. It is up to the legislative branch to

make those decisions. I have an example that may be controversial to some, but as a TBA House of Delegate Member, I have made my opinion known. I practice primarily in domestic relations. The Child Support Guidelines are problematic. The Guidelines often remove the discretion of the trial judge in favor of a calculation that can lead to an unjust result. The inclusion of child care and health insurance is noble. It should be there because those are costs that all parents face. The difficulty is that every circumstance is unique and does not fit conveniently into a box.

I have had a Father that paid One Thousand Two Hundred (\$1,200.00) Dollars per month in support for two (2) children. The Mother only had visitation every other weekend because of her lifestyle. She doubled her income because she had children, which she does not care for day to day. That is an issue, but the result is supported by the Guidelines.

Until the Guidelines are revised, it is law. The Child Support Worksheet is the current calculation that is mandated and must be upheld.
