- I have owned and operated a busy solo law practice as a general practitioner for just shy of 18 years. I have always managed a heavy case load, and I have conducted hundreds of trials and hearings in family law matters, criminal matters, juvenile dependent and neglect matters, probate matters, and general civil matters.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I am the sole attorney in a busy, small town law practice. In addition to my law practice, I am also listed as a Rule 31 Civil Mediator, Family Law Mediator, and Family Law / Domestic Violence Mediator. I practice in the following areas:

Family Law – 60% (including mediation)

Criminal Defense – 25%

Bankruptcy – 5%

Wills and Estate Administration – 5%

Civil Litigation – 5%

I conduct between 75 and 110 mediations per year, the vast majority of which are Family Law mediations. I am typically in court three or four days per week, either for trials or motion hearings. While I do some transactional work, my practice is primarily a litigation practice.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have always been blessed with a busy general practice. I typically appear in court three to five days per week. I have participated in approximately 30 jury trials. I have represented clients in hundreds of non-jury trials and countless motion hearings. I have appeared before the Court of Appeals and the Court of Criminal Appeals on multiple occasions. I have not yet appeared before the Tennessee Supreme Court. For the past six years I have also practiced regularly before the United States Bankruptcy Court for the Middle District of Tennessee. Early in my practice I regularly handled residential real estate closings, though I have not practiced in this area in many years. I have also represented clients in front of various county and city Planning and Zoning boards, Equalization Boards, and in front of the County Commission for Robertson County. While my practice has is primarily based in Robertson County, I also have litigated matters in Montgomery County, Sumner County, Cheatham County, Davidson County, Williamson County, Rutherford County, Wilson County, and Knox County. I have drafted hundreds of wills over the years, and this portion of my practice continues to grow as I get older. I have also assisted clients with the formation of business entities, although that is not a large part of my practice. I continue to take criminal appointed cases, and I am regularly appointed as Guardian ad Litem in divorce matters and conservatorship matters. I am also appointed by the Court in probate matters from time to time.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I have had a successful general practice for almost 18 years. I have continued to accept appointed criminal cases and juvenile dependent and neglect cases long after the time when most seasoned attorneys pass those cases on to young associates. It is our duty as lawyers to provide low cost or no cost legal services to those who could not otherwise afford our services, I am proud of the level of legal service that I have provided our indigent population over the years.

My practice has required that I represent people on occasion who have been involved in abusive relationships. It is very rewarding to have a hand in assisting victims of such domestic abuse find safety and gain the protection that the Courts and legal system provide.

I have handled many adoptions over the years. There is no better feeling as a legal professional than to participate in a final adoption hearing.

I have participated in multiple Wills for Heroes Clinics, as well as Legal Clinics for persons with limited economic means.

As stated earlier, I handle a large number of family law mediation cases each year. The experience that I have gained in mediating these cases has made me a better lawyer. I have had the opportunity to work with outstanding family law attorneys in bringing their cases to a successful resolution. I have learned so much about how to prepare and try a case from these outstanding attorneys. I feel that my mediation experience will be invaluable to me on the Bench if I am fortunate enough to be selected for this position. I have also experienced the frustration that I am sure judges feel when attorneys are unprepared for mediation. I am always prepared for court and mediation, and I would bring that same level of preparedness to the Bench.

I have been the sole attorney in a busy and successful law practice for almost eighteen years, after working in other offices for four years. I am now handling more family law matters than any other practice area. I truly enjoy what I do, and I could certainly

continue to operate my law office and be very happy.

I would like a new challenge. I have the relevant legal experience to be an effective domestic relations judge. I would be able to competently hear cases from the start, as I consider these issues daily in my private law and mediation practice.

This will be a busy court from day one. The Court Clerks have been instructed to begin assigning cases to Part 5 immediately, even though the successful candidate will not be able to start until September 1, 2018 at the earliest. I feel that I would not be overwhelmed by these busy dockets, as I have always maintained a heavy case load.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

The 19th Judicial District is a two county District which serves Montgomery and Robertson Counties. The State Legislature, recognizing the need for an additional judge in this Judicial District, created this position, with an anticipated start date of September 1, 2018. Currently there are four Circuit Court Judges and one Chancellor. The individual selected for this position will be the Circuit Court Judge for the newly created Part V. Judge William R. Goodman III, Presiding Judge of the 19th Judicial District, recently sent a Memorandum that spelled out the duties of the Part V Judge. This position will hear 80% of all Domestic Relations cases filed in Circuit Court, which equates to 40% of the domestic relations cases for this Judicial District. It is my understanding that this Judge will hear divorces, post-divorce modifications of custody and child support, modifications and enforcement of alimony awards, and contempt petitions.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

If selected to fill this position, I would uphold the law even if I did not agree with its substance. It is not the function of a trial judge to make law; that is the Legislature's role. A judge's role is to consider the facts and fairly and impartially apply the law to those facts. It is crucial that a judge uphold the law despite any personal feeling or misgivings that he or she may have.

As a practicing attorney, I know how important it is for the law to be consistently and fairly applied. It would be almost impossible to counsel clients in a custody modification case if the judge was known to apply different legal standards than the law requires.

Tennessee now requires that a judge fashion a parenting schedule that maximizes the participation of the Alternate Residential Parent in the child's life. This has led to some judges routinely awarding 50/50 parenting plans, even in situations where one parent has not been very involved with the child. There are also several statutory factors that judges

must consider in making these determinations. The case law is still being developed in this area, and any judge making these decisions will need to stay current on the appellate decisions that come out dealing with parenting plan issues. While I personally may agree that 50/50 plans are in the best interests of minor children in all situations, I would follow the law as it evolves in this area.
