My major area of practice is 100% Prosecution of *Driving While Impaired* drivers. This includes vehicular assault, aggravated reckless assault, drug possession, weapon charges, domestic assault, theft, as well as a plethora of other criminal charges based on evidence found during the initial arrest process.

Approximately 5% of my current case load is prosecution of vehicular homicides due to driving while impaired.

My entire career as a licensed attorney has been spent in the trial courts of General Sessions Criminal and Circuit Court Criminal.

I have conducted both, trials and hearings, in all of the trials courts of Montgomery County at various times in my practice of law.

For the past 6 years, I have practiced in the trial courts of Circuit Court Criminal, in all three Divisions, as well as Pro Tem in other counties. I have also practiced in every division and court in Montgomery county at some point over the past 12 years.

Additionally, through the help of the local judges, I was able to implement the use of Division I Cout, to hear DUI misdemeanor cases. It should be noted this court is different from a DUI court. This court hears all motions, settlements, and trials for DUI misdemeanor cases. Due to the numerous felony cases on the docket, DUI misdemeanor cases were being routinely overlooked or reset, and it would take up to 18 - 24 months for a case to go to trial. Through the use of this misdemeanor court, these cases are now being completed within 120 - 180 days.

Prior to obtaining my license to practice law, I was a Deputy Sheriff with the New Orleans Sheriff's Department in Louisiana. I also served as a Police Officer with the Crescent City Connection Police Department in New Orleans, Louisiana.

I have completed over 400 hours of Continuing Legal Education since obtaining my License to Practice Law. While the State of Tennessee would have required only 180 hours of continuing education during my 12 years in practice, I have exceeded that by 220 hours, approximately doubling the required minimum. I choose to consistently do this because I believe in keeping up to date with the law and the continued education courses allows me to understand how the changes affect the practice of law.

Additionally, for the past 6 years, I have taught and spoken at many events involving university students, law enforcement officers with local and county police/sheriff's departments (TN and KY), the Tennessee Highway Patrol, the Kentucky State Police, Ft. Campbell Military Police, Military Personnel and area District Attorneys on topics of DUI Prevention, Report Writing, Trial Preparations, and updates on Drugged and Drunk Drivers.

I once read an article called *The Qualities of a Good Judge*, which stated:

"Legal Courage is the willingness to do what the law requires the judge to do, even though the course the judge must follow is not the popular one. Integrity is not being influenced by the identity, race, gender, political status, wealth or relationship of the party or lawyer before the judge."

The majority of my adult years have been committed to serving my community and my country. I believe I possess many of the qualities of a "good judge" to include patience, tact, firmness, compassion, character, intelligence, as well as common sense. I believe my desire to continue to serve my community is needed by the public I seek to serve.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. *(150 words or less)*

The position I seek is Circuit Court, Part V Judge, in Montgomery and Robertson Counties. According to the 2017 census, Montgomery County's population is estimated to be over 200,000 and Roberson County is estimated at over 70,000. At this time, we have four circuit court judges who hear criminal and/or domestic cases. I believe the impact I can have as a judge for domestic matters will positively and directly affect the timeliness of when cases are heard with the efficiency and fairness in processing the current overload of cases in the circuit courts.

Additionally, I believe the judicial system should reflect the community it serves in the best way possible. I believe the skills and knowledge I possess, along with my legal experience, will help make that representation possible and allow our legal system to best reflect the demographics and populations in communities where I serve.

Yes. I will uphold the law even when I disagree with the substance of the law, statute, or rule.

A Trial Court Judge does not make the laws, but rather interprets and follows the laws set forth from legislation and the appellate courts while maintaining impartiality.

As a prosecutor, I had a defendant who was pulled over in a parking lot, less than 100 yards from where he started driving. The officer had observed behavior prior to and subsequent to the stop that made him suspicious. The driver admitted he had way too much to drink and should not be driving. He cried and pleaded to not be arrested because he needed his driver's license. Without his license, he was fearful it would result in losing his job with the military, and he was also concerned because his wife was 8 months pregnant. However, the TN statute does not give an option about the loss of driving privileges, whether you drive a yard or a hundred miles. As a result of the statute, I had to uphold the law and his driving privileges were revoked.
