I am an Assistant District Attorney General in the 24th Judicial District, which is composed of Hardin, Decatur, Benton, Carroll, and Henry Counties.

I was licensed to practice law in 2001, and my Tennessee BPR number is 021178.

I am licensed only in Tennessee.

I was a partner at McGee & Dennis, Attorneys at Law, in Savannah, Tennessee, from July 2001 until November 2014. I have been an Assistant District Attorney General in the 24th Judicial District since November 15, 2014. I also served as a State Representative for the 71st House District in the Tennessee General Assembly from November 2008 to November 2014.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My current practice consists almost entirely of prosecuting criminal offenses in the General Sessions and Circuit Courts of the 24th Judicial District. As the chief prosecutor for Hardin County, I am responsible for prosecuting almost all criminal cases brought before the General Sessions and Circuit Court of Hardin County, which constitutes approximately ninety percent of my total practice. For the remaining ten percent, I assist with prosecutions as needed in other Counties in our district, and occasionally as a pro tem prosecutor in other districts.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

While in private practice, I represented individuals, business entities and government organizations in a wide variety of legal matters, including criminal defense, divorce and custody matters, civil litigation, real estate, probate, and various other legal and business issues. I practiced in many of the General Sessions, Circuit, Chancery, and Appellate Courts of West and Middle Tennessee.

Since November 2014, I have been a prosecutor as described in the previous paragraph.

During my service in the Tennessee General Assembly, I drafted and sponsored dozens of bills and legislative proposals, many of which becoming State law. Most of my legislative proposals centered on civil and criminal policy issues. In addition, I was responsible for reviewing the impact and propriety of hundreds of legislative proposals each year in my capacity as a member of the House Judiciary, Civil Justice, and Health committees and subcommittees.

I have fond memories of numerous worthy battles in the Courtroom and the State Capitol. While each is of special note to myself and the clients, advocates, and/or citizens involved, there are none that sufficiently stand above the others to list individually in my humble opinion.

I am seeking the position of Chancellor for the 24th Judicial District of Tennessee. Our judicial district is composed of Hardin, Decatur, Benton, Carroll, and Henry Counties. It stretches from Mississippi to Kentucky. Approximately 1,200 cases are filed in Chancery Court throughout our District each year. Chancery Court resolves almost all domestic proceedings filed in four of our five counties, in addition to the many adoptions, contract disputes, boundary disputes, and other matters of an equitable nature that fall within its jurisdiction. My extensive experience in our Circuit, Sessions and Chancery Courts over the last eighteen years will allow me to fairly, expeditiously, and efficiently manage the substantial dockets found in each of our five counties.

Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I will most certainly uphold the laws of our State and Country, regardless of personal beliefs, if I am allowed to serve as Chancellor.

In 2011, our state legislature passed the Exclusionary Rule Reform Act, codified at T.C.A. 40-6-108, which attempts to prohibit suppression of evidence acquired pursuant to a defective search warrant in many situations if the error giving rise to the defect was made in good faith. I was a vocal opponent of this legislation, primarily because I believed it encouraged careless behavior on the part of government when intruding on a fundamental constitutional right. Despite my vigorous opposition, the legislation was swiftly approved and codified.

Upon my retirement from the legislature in 2014, I was often called upon to vigorously defend the act I had so recently and vehemently opposed as I began my new career as a prosecutor. While I still had reservations about the wisdom of the act from a policy perspective, I nonetheless defended its application wholeheartedly as I opposed the suppression of evidence in my cases. Regardless of my personal reservations, I fought for application of this statute because it was my duty. Fortunately, at least from my personal perspective, recent case law has reigned in many of my concerns about the statute in question. Even so, remaining concerns will not alleviate my duty and responsibility in this or any other matter to follow the law as created by our legislature and interpreted by our Courts to the best of my ability.
