6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I am currently not engaged in the practice of law as I am a Judicial Commissioner.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

My entire legal practice has been almost entirely in the Walter L. Bailey Criminal Justice Center located at 201 Poplar in Memphis, TN. I have practiced in every court in the Criminal Justice Center.

I was hired as an Assistant District Attorney in 2008. As a new prosecutor, I was assigned to the General Sessions Courts. My duties in that role included managing the daily court docket, making offers on misdemeanor cases, and conducting bench trials on misdemeanor cases.

In 2009, I was assigned to the Felony Team. My duties included negotiating and conducting preliminary hearings on felony cases.

In 2010, I was assigned to the Domestic Violence Prosecution Unit. As a member of the Domestic Violence Prosecution Unit (DVPU), I handled cases that involved intimate partner violence. Since DVPU is a vertical unit, I handled cases from the Arraignment setting in General Sessions to Jury Trial in Criminal Court. In this role, I had the opportunity to try a variety of cases including Domestic Assaults, Kidnappings, Aggravated Burglaries, Aggravated Assault, Aggravated Rape, Aggravated Arsons and Homicides.

In 2014, I was assigned to Criminal Courts. In addition to trying cases, I also gained experience conducting various hearings including Petitions to Revoke Suspended Sentences, Petitions to Suspend Remainder of Sentence, Petitions for Post Conviction Relief and Sentencing Hearings.

In 2017, I was reassigned to the Domestic Violence Prosecution Unit where I resumed the same duties.

From 2018 until 2022, I was assigned to the DUI Unit where I prosecuted cases involving impaired drivers such as Driving Under the Influence, Vehicular Assault, and Vehicular Homicide.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

State v. Marquell Griffin: On March 21, 2019, Memphis Police Department Lt. Fair was

stopped at a red light when Marquell Griffin crashed into his vehicle at a high rate of speed. Lt. Fair died on the scene. Marquell Griffin was under the influence of alcohol at the time of a crash. Griffin pled guilty to Aggravated Vehicular Homicide, Leaving the Scene of the Accident, and Possession of a Controlled Substance with Intent. He was sentenced to an effective sentence of 27 years.

State v. Robert Earl Jackson: On March 9, 2021, Memphis Police Office, Nicholas Blow was leaving the Raines precinct when his car was struck by Robert Earl Jackson who was under the influence of alcohol. Officer Blow died from injuries sustained in the crash. Robert Earl Jackson pled guilty to Aggravated Vehicular Homicide and was sentenced to 15 years.

<u>State v. Michael Davis</u>: On November 29, 2011, Michael Davis fatally shot Lakesha Applewhite. He was subsequently indicted and found guilty by a jury of Second-Degree Murder. Michael Davis was sentenced to life imprisonment without the possibility of parole as a repeat violent offender.

State v. Brown: On August 13, 2012, Andre Brown arrived unannounced at the victim's home in Southaven, Mississippi. Andre Brown forced the victim into his vehicle and transported her to his brother's home in Memphis where he cut her arm with a box cutter, tased her and forced her to have penile and vaginal sex. He was subsequently indicted and found guilty by a jury of Aggravated Rape, Aggravated Kidnaping, and Domestic Assault and sentenced to 30 years.

State v. Frazier: On September 23, 2023, the defendant approached the victim outside a car dealership in Memphis. Michael Frazier pointed a gun at the victim and demanded that she give him money. When the victim stated that she did not have any money, Michael Frazier forced the victim to drive to the Walmart Money Center to get money. Michael Frazer remained in the car at Walmart and the victim went inside where she alerted Walmart employees of the situation. Law enforcement was contacted, and Michael Frazier was arrested. Michael Frazer found guilty by a jury of Especially Aggravated Kidnapping, Aggravated Robbery and Carrying a Firearm with the Intent to go Armed and sentenced to an effective sentence of 35 years.

<u>State v. Jones</u>: On May 21, 2012, Officer Blockard, a Memphis police officer, was booking Dewayne Jones into the Shelby County Jail when Dewayne Jones hit the officer in the face, knocking him unconscious and fracturing his jaw and cheekbone. The defendant was indicted and found guilty by a jury of Aggravated Assault. He was sentenced to five years.

<u>State v. Jones</u>: The victim, a 12-year-old girl, reported that her father, Dewayne Jones, raped her three times between January and February 2013. Dewayne Jones was indicted and convicted by a jury of Rape of a Child, Aggravated Sexual Battery, and Incest. He was sentenced to 35 years.

State v. Douglass: On September 12, 2012, Tracy Douglass shot and killed his girlfriend, Chekisha Scott, in front of her home and left her body on the sidewalk. He was subsequently indicted and convicted by a jury of First-Degree Murder. He was sentenced to life imprisonment.

During my third year of law school, I served as an Extern with the Knox County Public Defender's Office. This gave me the opportunity to experience the criminal justice system from the defense perspective.

The plaintiffs, Just City et al, brought suit against the Shelby County Judicial Commissioners in our professional capacities and one General Sessions Judge who served as the administrative judge over the Judicial Commissioners seeking injunctive relief and challenging the constitutionality of House Bill 1719. House Bill 1719 prohibits a magistrate from considering a defendant's ability to pay when determining a bail amount.

I love Tennessee, and I have a deep heart for the citizens of Shelby County. I have devoted my entire career to public service, and now I would be honored to continue that service as Judge of Criminal Court Division 1.

Criminal Court Division 1 needs a judge who is both competent and knowledgeable. I have worked in every facet of the criminal justice system, giving me the institutional knowledge and experience required to serve effectively.

In addition to my legal expertise, I bring a fair and respectful demeanor that is essential for the bench. Throughout my career, I have made it a priority to treat all parties—litigants and attorneys alike—with dignity and respect.

I am ready to bring my dedication, experience, and integrity to the bench and serve Shelby County with the commitment it deserves.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges. and explain how your selection would impact the court. (150 words or less)

I am seeking appointment to Criminal Court Division One in Shelby County. Shelby County is a large metropolitan area with a population of 910,000. The nine Shelby County Criminal Courts handle approximately 207,000 cases annually. This volume places a significant demand on judicial efficiency and case management.

Currently there is a backlog of cases in the court system. This delay causes frustration for all parties involved. Crime victims are left waiting for closure and the accused are denied timely access to justice. These delays not only impact the lives of the parties involved, but also undermine public confidence in the justice system.

If appointed, my immediate priority would be to address this backlog and improve the pace at which cases move through Criminal Court One. I would begin by requesting a list from the Clerk's Office of all cases pending for over a year without a trial date. Each of these cases would be reviewed to determine the reasons for and possible solutions.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes, I will uphold the law even if I personally disagree with its substance. I firmly believe that there are distinct roles within the criminal justice system, and as both a former prosecutor and now a judicial commissioner, I understand that my role is not to question the law based on personal views. I have taken an oath to follow the law faithfully, regardless of personal feelings or policy preferences.

In my work as a prosecutor, I was occasionally faced with charging decisions or sentencing outcomes required by statutes with which I may not have personally agreed. However, I recognized that my duty was to apply the law as it stood—not as I might wish it to be. Similarly, in my role as a judicial commissioner, I am committed to impartiality and strict adherence to legal standards.

The responsibility for questioning or changing laws rightly belongs to legislators, social advocacy groups, and lobbyists whose role is to shape public policy. My responsibility is to interpret and apply the law as written, ensuring fairness and consistency for all parties under the legal framework.

My professional experience has reinforced the importance of maintaining these boundaries. Upholding the laws, even when one disagrees with them, is essential to the integrity of the justice system and the public's trust in it.
