

Tennessee Code Annotated section 17-4-301 et seq. charges the Trial Court Vacancy Commission with assisting the Governor and the People of Tennessee in finding and appointing the best qualified candidates for judicial offices in this State. - 6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I solely practice civil law. My practice is litigation based and is almost entirely defense focused. The major areas of law in which I practice are personal injury defense (60%), breach of contract/bad faith insurance claims (15%), insurance coverage (10%), professional negligence (5%), general tort defense (5%), and commercial litigation (5%).

In my personal injury defense practice, I mainly handle cases involving automobile/trucking accidents and premises liability cases. The majority of those cases involve insured individuals or entities. However, I also represent self-insured entities and sometimes uninsured individuals and entities. I also work directly for insurance companies on breach of contract/bad faith claims. Those types of cases involve first-party disputes between insureds and insurers. Additionally, I handle coverage investigations for insurance companies and conduct examinations under oath while investigating claims. My professional negligence practice mainly consists of defending real estate agents and brokers in disputes with buyers or sellers. Although, I have also been involved in defending legal malpractice cases. Finally, I represent individuals and entities in commercial litigation cases involving fee disputes, contract disputes, and workmanship disputes.

Overall, my practice has largely been consistent in these areas since I became licensed as an attorney in 2012. I routinely draft pleadings, complete written discovery, conduct depositions, participate in mediations, and attend court for hearings and trials. I also spend a great deal of time meeting with my clients to obtain information needed for the defense of their cases.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I am licensed in Tennessee and Mississippi. Also, I am admitted to the U.S. District Courts for the Western District of Tennessee and the Northern District of Mississippi. The majority of my work is conducted in Tennessee, but I obtained my Mississippi license in 2021 and have also practiced in the state trial courts of Mississippi over the past four years. My practice is approximately 70% in state court and 30% in federal court. I often litigate trucking cases, premises liability cases, and insurance disputes in federal court. The amount of time I have spent in federal court has increased throughout my time in practice, but in the early years of practice, I spent the large majority of my time in state court.

On a weekly basis, I am typically in court at least one to two days per week. The majority of those court appearances are in Shelby County Circuit Court. Aside from Shelby County, I also

practice in the neighboring counties and other counties in West and Middle Tennessee, as well as North Mississippi.

I became licensed in 2012, and I tried my first bench trial in early 2013 in Shelby County General Sessions Court. In 2015, I tried my first jury trial in Shelby County Circuit Court. Since then, I have tried a number of jury trials in both state and federal court. Also, I have tried countless bench trials in state court. Further, I have extensive experience with motion practice in both state and federal court. I have spent a considerable amount of time in the Shelby County Civil Court, and I have been fortunate enough to develop great relationships with both the judges and other staff throughout my years of practice.

My appellate practice is somewhat limited compared to the amount of work I have done in the trial courts. I have argued several times before the Tennessee Court of Appeals, but I have never been involved in a matter in front of the Tennessee Supreme Court. In federal court, I have been involved in two matters that were appealed to the Sixth Circuit. Those matters were decided on briefs.

Over the course of my career, I have handled approximately 10-15 workers' compensation settlement hearings. Aside from those hearings, I do not have any other experience practicing in front of administrative bodies or legislative/regulatory bodies. I also have not handled any type of transactional cases.

Overall, due to the nature of my practice, I have extensive experience practicing in the trial courts of Tennessee. As noted above, my practice areas have largely been consistent throughout my career. This has allowed me to become very comfortable and confident in my role as a litigator, both in and out of court.

I find this aspect of the practice highly rewarding.

Now, I am ready to serve the community as a whole by becoming a judge here, where I was born, raised, and where I am now raising my family. I want the citizens of Shelby County to be confident that they have a judge who will administer justice in a reliable and efficient manner. I will build upon the strengths of our local justice system and improve on any weaknesses. If I am appointed to this position, I believe I can make a long-term positive impact on the life of not only the litigants but also their attorneys. I know that my many years of experience practicing in Shelby County will allow me to serve the community with confidence and provide a firm but fair application of our laws.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking to be appointed to the open judgeship for Shelby County Circuit Court, Division 3. Shelby County encompasses the Memphis metropolitan area and surrounding municipalities. It is the largest county in Tennessee, both in population and area. Historically, there have been nine divisions/judges. However, in 2024, Division 7 was eliminated. Once this appointment is made, there will be eight presiding judges in Shelby County Circuit Court. This Court handles civil matters including tort claims, family law, healthcare liability, personal injury cases, and other cases in which juries are requested. The Court also handles non-jury matters such as Tennessee Governmental Tort Liability Act claims. If the Governor appoints me to this position, I will work with the current judges to provide the citizens of Shelby County with an efficient and impartial system in which to resolve their civil disputes in a timely manner.


Yes. I believe that becoming a judge is the ultimate privilege within the legal system. However, with that privilege comes great responsibility, including the application of the law as written despite any subjective feelings on the substance of the law. As a lawyer, I am already bound by the Rules of Professional Conduct. However, if I was appointed to this position, I would also be bound by the Code of Judicial Conduct. I do not take these requirements lightly, as the ethical and moral obligations we have in this profession are of the upmost importance.

In my practice, I have dealt with a number of scenarios where I have had to either take action or abstain from taking action on behalf of my client based on certain laws and rules of procedure even when I knew that I might personally disagree with the outcome. For example, I have had several cases where I knew that my client was liable for the actions complained of by the

plaintiff, but, in order to zealously represent my client, I had to file motions to dismiss based on procedural and legal insufficiencies. While I sympathized for the plaintiffs, I had to take these actions in order to fulfill my obligations to my clients, and the motions were soundly based in law and fact. Similarly, if I receive this appointment, I will apply the law in a fair and impartial manner regardless of how I may feel personally about the consequences of my rulings.
