28. What are your reasons for seeking this position? (150 words or less)

I am seeking the position of Judge of Criminal Court for Knox County because I am the most qualified and experienced for the position and I have the temperament and patience to handle the large dockets. I am distinguished from the other candidates in that I have acted as both a prosecutor in Georgia and Tennessee and have practiced as a criminal defense attorney. I have tried over 100 jury trials in the span of my career in both civil and criminal courts and am well versed in the law of evidence, discovery, statutes, and sentencing. As a prosecutor, I was accustomed to handling very large dockets which is necessary for the position. I get along well with both prosecutors and defense attorneys and I will uphold the rule of law as the oath requires.

I am applying for the vacancy left by Steven Sword for the Criminal Court in Knox County, Tennessee(Division I. There are 3 Criminal Court Judges for Knox County. My selection will bring some diversity to the Court because there has only been one other woman that has served in this role in Knox County. I am in a position to manage the long dockets because I have had experience with that during my years as a prosecutor. I am also distinguished because I have worked as both a prosecutor and defense attorney which puts me in a unique position to understand both roles. I understand the need for due process in the court system and the need for defendants to be afforded a fair trial as well as the rights of victims in the criminal court system.

Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes, I will uphold the law even if I disagree with it. One example that comes to my mind as a defense attorney is mandatory sentencing in many cases. I experienced this issue last week where I represented an individual who was a career offender but had not had any convictions since 2008. He was charged with an E felony and we had a jury trial and he was convicted. The judge had to sentence him to the only sentence possible which is 12 years@60%. Unfortunately, the judge had no discretion in this matter. The 12-year sentence seemed extremely harsh given his good behavior for the last 17 years. He was charged with possessing a very small amount of drugs and bringing it into the penal facility. He was homeless and an addict. Another example I have seen are circumstances where victims do not believe that the system is just in situations where judges have very little discretion in the sentencing based on the class of the crime or the range of a defendant. For example, where a defendant gets 6 months of unsupervised probation for offensive contact to a child.
