<u>January 2018 – Present: Special Judge, Davidson County General Sessions Court.</u> I currently have a standing order from the Chief Justice of the Tennessee Supreme Court to serve as a special General Sessions Judge as needed. Although I have filled in for every General Sessions Judge in Davidson County, I typically serve on the Domestic Violence and Order of Protection dockets.

<u>September 2004 – Present:</u> I am a trial attorney who is a solo practitioner maintaining a general practice of both criminal and civil cases. My primary areas of concentration are criminal law, family law, personal injury litigation, contract litigation and probate law. I also serve as a Rule 31 listed civil and family mediator and have conducted both tort and family law mediations.

September 2001 – September 2004: Law Clerk for the Honorable Steve R. Dozier, Judge of Division 1 Criminal Court – 20th Judicial District. I was fortunate to serve as a Law Clerk/Court Officer in Division I Davidson County Criminal Court. My responsibilities included drafting Order on matters concerning bond, suppression issues, motions for new trial, sentencing memorandums, severance, 412 and 404 (b) issues, Post-Convictions Petitions, Habeas Corpus Petitions and motions in Limine. I drafted Rule 12 reports to the Supreme Court and conducted extensive research on a wide range of criminal jurisprudence. As a Court Officer, I transported inmates to court, oversaw the care and control of empaneled and sequestered juries and participated in court with almost one hundred (100) jury trials including death penalty cases.

<u>August 2016 – January 2018: Councilman – Davidson County Metropolitan City Council.</u> I was elected in August 2016 to fill the vacant District 1 Metro Council seat. District 1 is geographically the largest councilmanic district and includes the communities of Bordeaux, Joelton, Scottsboro/Bells Bend and Whites Creek. This councilmanic district has the second highest number of minority constituents in Davidson County and the needs between each community are as varied and distinct as the people.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I am a general practitioner and consider myself a trial lawyer with ninety percent (90%) of my practice being litigation in courtrooms in Nashville and Middle Tennessee. I have consistently practiced criminal, family and general civil law since I was licensed in 2005. Criminal law is approximately fifty percent (50%) of my practice, family law comprises twenty-five percent (25%) and general civil litigation comprises the remaining twenty-five percent (25%).

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have practiced law in General Sessions and State Trial Courts before every judge and chancellor, in the Twentieth Judicial District. My practice has also taken me to most of the state trial courts in the Middle Tennessee area. The experience of handling different subject matters in different courtrooms around the state provides me with a unique personal perspective on how courts transact business differently. I have observed models that appear to operate more efficiently for lawyers and litigants I and seek to bring this efficiency to Division III Criminal Court if selected.

I have handled numerous criminal cases before all the Criminal Court judges in Davidson County. Although most of my cases are resolved in negotiated plea agreements, I have averaged approximately one (1) jury trial per year. Examples of criminal charges that I have handled include but are not limited to: murder, aggravated sexual battery and rape of a child, aggravated burglaries and assaults, kidnapping, possession of controlled substances for re-sale and

conspiracies involving "Drug Free School Zone" charges with multiple co-defendants, "crooks with guns" charges, multiple offense DUIs, sex offender registry violations, domestic and simple assaults, probation violations, community-corrections violations and sentencing hearings. Additionally, I have extensive experience in post-conviction and habeas corpus petitions and that knowledge is essential for all criminal court judges. I was once successful on a Post-Conviction Petition and that is extremely rare given the elements and heightened standard of proof required to prevail. My criminal practice routinely includes motion practices in matters regarding bond, suppression, dismissal, severance, new trial, *limine*, T.R.E. 404(b) and 412, and requests for special jury instructions.

A large portion of my practice consists of probate and general litigation in circuit and chancery courts. I have served as lead counsel in million-dollar collections cases, GTLA litigation, contract and personal injury cases, wrongful death cases and workman's compensation cases. As it pertains to probate matters, my practice has included conservatorships, guardianships, administration of estates and trusts, will contests, muniment of title petitions and serving as an attorney ad litem. I have also drafted numerous wills, trusts, living wills and durable powers of attorney for clients. There have been times in my practice when a client needed immediate relief, and the pace of litigation was not sufficient to protect their interests. As a remedy, I have initiated multiple chancery court actions requesting extraordinary relief in partnership matters, corporate dissolution matters, and cases seeking rescission or reformation of poorly drawn contracts. Additionally, I have filed certiorari petitions in chancery court challenging decisions by administrative agencies in matters regarding the Tennessee Sex Offender Registry, liquor and beer regulations, aquatic resource alteration permits and anti-degradation.

Domestic Relations cases are another substantial part of my civil practice. I have handled divorce cases, adoptions, orders of protection, grandparent visitation cases and parenting time disputes. Aside from divorces, the majority of my family law cases are post-divorce modifications of child support, parenting time and alimony. As a result of the 2011 amendment to Tenn. Code Ann. § 36-6-106(a), I am filing more post-divorce petitions on behalf of qualified fathers seeking to modify residential parenting schedules in effort to maximize their participation in the life of their children

Appellate Court litigation also comprises a small portion of my practice. I have filed direct appeals to the Tennessee Court of Criminal Appeals after clients have been convicted. Additionally, I have represented clients in the Tennessee Court of Criminal Appeals seeking review of post-conviction and habeas corpus rulings. I have handled appeals of orders of protection, probate matters, tort and contract claims in the Tennessee Court of Appeals. I have also made Rule 9 T.R.A.P and Rule 10 T.R.A.P. applications to the Tennessee Appellate Courts. I strongly believe that appellate practice enables attorneys to be more effective as trial lawyers.

I have appeared before administrative agencies, local beer boards and state administrative law judges. I have sought relief in administrative appeals for clients that have been indicated. I once successfully filed a pro bono administrative appeal, on behalf of a family whose son was murdered, seeking an award from the victim's compensation fund. In the past few years, I have been involved in administrative contested cases at the state level. I previously represented the Sierra Club in a four (4) day trial in an administrative proceeding against TDEC challenging the

issuance of ARAP permits and TDEC's application of the Anti-Degradation rules to the destruction of an ETW wetland in Cookeville, Tennessee.

In the past few years, I have engaged in more document drafting and transactional work for various clients buying and selling going concerns such as landfills, recycling centers and medical and dental practices. Examples of recent documents I have drafted are: asset purchase agreements, lease purchase agreements, guarantor or surety agreements, non-disclosure agreements, assignments, options, commercial leases and corporate agreements.

In my role as a special General Sessions Judge, the majority of matters I hear are domestic violence cases and orders of protection. Respect begets respect and when a judge is respectful of everyone in the courtroom the process is a better experience overall. Since presiding over these cases, I have had a positive impact on how we handle domestic cases and specifically orders of protection. It is my practice to ensure whatever action the court takes on orders of protection that the litigants leave the courtroom with the most updated copy of that order. In many instances, litigants left the courtroom, and the order was mailed to the last known address and that is not effective for pro se litigants in a general sessions' arena. I have also taken been an advocate in firearm dispossession paperwork for both domestic assault convictions and those under an order of protection.

Domestic violence cases are vastly different from other criminal matters. As a judge, I strive to ensure each party has the opportunity to tell the court everything they deem relevant and leaves the courtroom satisfied that the court heard and understood their position. While serving as a judge, both the defense bar and district attorneys find me to be a judge that is fair and always strives to follow the law and allows everyone to be heard. Once I remember even stepping down from the bench and sitting on a pew in the gallery to fill out paperwork to waive class fees for indigent defendants when the clerk was not present. I believe being a good judge is knowing when the law requires you to act, rather than constantly exercising the extent of your authority.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

First Tennessee Bank National Association v. Shelby Village Mobile Home Park, LLC, et al. 2014WL4217404 (Tenn. Ct. App. June 22, 2015 at Nashville) – This case went all the way to the United States Supreme Court and certiorari was denied. (135 S.Ct. 2862 cert. denied 6/22/15) This case involved several state and federal issues stemming from the sale of a mobile home park by my clients to a third party. The park was destroyed in the 2010 flood and my clients remained guarantors by accommodation on the underlying note. The purchases defaulted on the note. The bank sued all parties to the transaction and attempted to use the cross-collateralization provisions in the instant note to call forty (40) unrelated notes due at the same time in an effort to force my clients to pay immediately or seek the protection of an automatic stay in bankruptcy court. My clients prevailed in the trial court, Tennessee Court of Appeals

and The United States Supreme Court.

<u>Heather Waterhouse v. Troy Waterhouse</u> – (04D-531) This was a post-divorce matter in Davidson County Fourth Circuit Court wherein I represented the mother and was awarded an upward deviation from the Child Support Guidelines in the amount of \$6,700 per month. The Court entered the order on February 13, 2017.

<u>2008 – Present</u>: I serve as the CBS Legal Analyst for the News Channel 5 Network here in Nashville. In addition to regular weekly interviews, I also cover gavel-to-gavel criminal trials in real time. I have participated in over 1,200 hours of live television covering criminal trials over the years and have been twice nominated for an Emmy. During our trial coverage, the trial is aired live, and during a recess or lunch break, I take live phone calls on the air with my cohost Nick Beres.

<u>April 2017</u>: I applied for the Division II Criminal Court Vacancy in the 20th Judicial District. I was one of the three (3) candidates that were selected by this Honorable Commission. Governor Haslam chose then Division III General Sessions Judge Angie Dalton to fill the Division II Criminal Court vacancy.

<u>December 2017</u>: I applied for the Division III General Sessions Judge vacancy with the Davidson County Metropolitan City Council and was appointed by a majority vote in January 2018 to fill the vacancy.

<u>August 2018</u>: I applied for the Division IV Criminal Court Vacancy in the 20th Judicial District. I was one of the three (3) candidates that was selected by this Honorable Commission. Governor Haslam chose then Deputy Attorney General Jennifer Smith to fill the vacancy.

Neal & Harwell represent us and there is a pending 'Rule 12 Motion to Dismiss which I expect to be granted as to all our actions, as set forth in the complaint, were taken in our councilmanic capacities.

<u>Dominic J. Leonardo vs. Canyon Inflatables, LLC a/k/a Saturn Rafts</u>, (24GC11884) Davidson County General Sessions Court. This is a breach of contract, warranties and violation of Tennessee Consumer Protection Act and Unjust Enrichment case currently pending.

28. What are your reasons for seeking this position? (150 words or less)

As I humbly seek to improve upon and ensure the public's access to justice, I am compelled to apply for this vacancy. My background allows me to relate equally to both alleged victims and defendants making me cognizant of the importance of creating and maintaining a courtroom environment wherein the state and defense are held to the same firm and uncompromising standards. Integrity, compassion, temperance, diligence and work ethic are essential attributes that should be reflected in our judiciary to ensure public confidence in our criminal justice system. I have consistently demonstrated these attributes as an attorney and judge. If appointed, I am comfortable and confident I can hold the office in the upcoming election as I previously ran three contested elections and remain very actively engrained in the Nashville community as a former Metro Councilman and former General Sessions Judge.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am currently seeking to fill the vacancy in Division III Criminal Court. The six (6) Criminal Courts in the 20th Judicial District preside over cases ranging from DUI to death penalty cases. As of June 1, Division III had 652 pending cases and that number has been increasing over the past six (6) months. I believe we are seeing a higher number of cases proceed through the system accompanied by a sharp spike in the amount of time it takes bond cases to reach a resolution. I would have an additional settlement docket on Thursdays at 1 p.m. to bring more bond cases to resolution. I have an unparalleled work and intend to maximize my availability for bench trials on smaller offenses and firmly believe both sides would find this effort beneficial. If appointed, I am committed to having a docket five (5) days a week.

As a Judge, you take an oath to uphold the Constitutions of the United States and Tennessee, as well as the laws of this state. It is inappropriate for a Judge to exercise their personal, political or sociological beliefs from the bench. Judges do not make the law, rather, they are required to uphold and impartially implement laws passed by Congress or the Tennessee General Assembly.

As an attorney, I have always been an advocate for one side of an adversarial proceeding. Advocacy is a job that I take very seriously and maintain pride in my craft. I have zealously represented clients and protected their legal rights even though I may have a personal aversion to the acts they committed. At each court appearance, I ethically advocate for my client's side of the facts and occasionally find that the other side has just as much merit and that I could ethically argue the opposite position just as easily. There have been occasions in my practice

when I may disagree with a court's ruling and would have applied the facts to the law differently as the judge. I acknowledge there are times when a law should be challenged and as an attorney I did so without hesitation. As a judge, my role is to be a neutral steward of the law and champion of the legal process and its consistent and fair application.
