I was also admitted to the MI bar in 2013, but did not complete the licensure process as my wife and I decided to move back home to TN.

I voluntarily went inactive with the TN Bar from September, 2023 through August, 2024, to be a stay-at-home dad to my four young children in support of my wife's career. At the time she was codirector of a counterterrorism center, which required frequent travel.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My practice has always been focused on indigent defense. I have mostly done dependent-neglect work, but have also done quite a bit of criminal defense. I currently have about 85 cases. 2 of those are in the Court of Criminal Appeals. Another 15 are in various criminal courts in Davidson County. A couple more are bound over from Davidson County General Sessions. On the other 65 or so, I am Guardian ad Litem.

 Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

Since becoming licensed in 2013, I have always worked as a solo practitioner, without an assistant, personally handling all aspects of practice. I have done a significant amount of work in juvenile, general sessions, and criminal courts across various Middle TN counties. I have tried many cases, including a criminal jury trial in Williamson County and a criminal jury trial in Davidson County. I have also done roughly 10 appeals in the CCA. On the civil side, I have tried multiple civil cases in Davidson County Circuit Court and pursued two appeals in the Court of Appeals. Additionally, I litigated a civil rights suit in federal court.

 Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I have had several successes in the Court of Criminal Appeals: (1) In State v Bart Leo Tucker, M2016-01960-CCA-R3-CD, the CCA reversed and dismissed a conviction and associated 5-year sentence for Worthless Check by accepting my "verbal postdating" theory, ultimately ruling that the evidence was insufficient. I was also the trial attorney; (2) In State v Darren Marion Little, M2022-00738-CCA-R3-CD, I obtained a remand for the trial court to sentence the defendant in a lower range, which ultimately resulted in an approximately 5-year sentence reduction; (3) In Joshua Allen Felts v State, M2022-01736-CCA-R3-PC, I obtained a reversal of 4 theft convictions based on ineffective assistance of counsel for failing to object to hearsay. Those charges were ultimately dismissed. Additionally, I am currently awaiting a decision from the CCA that, if successful, would be the first time in TN history that an appellate court applies Ex Post Facto protections to the Sex Offender Registry.

 - 10. I have been an Arbitrator for the Financial Industry Regulatory Authority since 2019. In this capacity, I have been part of prehearing events for several cases, but only one proceeded to arbitration. I was on a panel of 3 that decided the case after a week-long

hearing, including expert witnesses. Since then, I have been qualified as a Chairperson Arbitrator and am currently assigned as such to a pending arbitration. I have also served as "special judge" in Davidson County Juvenile Court and, until the pandemic, regularly presided over Youth Court, a diversionary program held in Davidson County high schools. Also, I have significant experience defending against Orders of Protection ("OPs") and allegations of OP violations.

I applied to be on the Court of Criminal Appeals in late 2020. At the time, I was 37 and was the only applicant under 40. It was obvious that I would not be selected, but it was important to me to gain experience in the application process.

The program was difficult because it required passing 4 comprehensive examinations—Epistemology, Ethics, Metaphysics, and one optional field. My optional field was Philosophy of Law. During this program, I served as a teaching assistant in several courses. Earning this MA allowed me to first be hired as an adjunct philosophy professor at age 24.

I have been the subject of roughly a dozen bar complaints since beginning practice in 2014. I have been asked to respond to a handful of these. They were all dismissed without the need for a hearing.

Yes. Two creditors registered judgments against me in 2024. Additionally, one of those creditors attempted to garnish my wages in 2024.

Yes, I filed Chapter 7 Bankruptcy in 2024. Discharge was granted.

Yes.

- -In November, 2024, my wife and I filed an Eviction against Kenneth Williams and Cayetona Quinn, which was granted: 24GT11950.
- -As previously disclosed, I filed for Chapter 7 Bankruptcy in 2024, #3:24-bk-04331 in the U.S. Bankruptcy Court for the Middle District of TN.
- -In 2022, I sued Victor Abbott in Davidson County General Sessions Court for unpaid legal fees, which were granted and subsequently collected in full: 22GC8492.
- -In 2017, I was a respondent in Christian v Reynolds-Christian. This was a civil rights action in the US District Court for the Middle District of TN, 3:2017cv00809. Basically, the mother of a child who had long been in DCS custody tried to sue everybody involved in the case. As former GAL for her child, I was included. The case was immediately dismissed against me because I was not a government actor and, thus, could not be subject to a §1983 claim. The case was only even brought to my attention after this dismissal.
- -In 2014, I obtained an Order of Protection against Minki Feigerle in Davidson County General Sessions Court, Case # 14OP2215.
- -In 2002, I was charged with misdemeanor theft in Davidson County. The case was dismissed and expunged.
- -Significantly, I have recently been involved in a cluster of OP cases. This is very complicated. The core of these cases is that I protested the prudish, provincial attitudes of a cluster of neighbors by wearing colorful underwear I named my "Amicus Briefs" on the public street near my house, spurring four different neighbors to seek OPs against me based on a "stalking" theory. This resulted in numerous cases, as follows. (1) In 22OP2599, in Davidson County General Sessions, Chris Lance sought an OP against me, which was denied after a hearing. (2) The other three were granted in General Sessions then heard *de novo* in Davidson County Circuit Court as Case #s 22X886 (Brian Johnson), 22X889 (Kate Johnson), and 22X890 (Linda Lance). These were initially filed in 2022, litigated in 2023, and nominally granted in 2024. My position is that all of the orders issued in 2024 were *void ab initio* due to noncompliance with both constitutional protections and statutory requirements. 22X886 has expired, so that is a non-issue. Mrs. Lance sought an extension of 22X890 in 2025, but that was denied so that order has also expired. An extension was granted to Mrs. Johnson in 22X889, which is currently under review by the Court

of Appeals. It is noteworthy that Mrs. Johnson alleged that the OP had been violated, but the Circuit Court ruled that there had been no violation. (3) The appeal of the Extension, M2025-00198-COA-R3-CV, has been submitted on briefs and is awaiting decision. (4) I was criminally charged in 2025-A-423 for allegedly violating the OP in 22X890 (the same OP that the Circuit Court ruled had not been violated). That charge has been retired without costs, as it was already determined through litigation that no violation occurred and there are strong reasons to believe the OP was invalid. Perhaps oddly, but worth mentioning, Judge Cheryl Blackburn, whom I am applying to replace, presided over that retirement, which provided me with the opportunity to congratulate her on her own retirement.

It is also worth noting that this case cluster involves significant constitutional and structural issues about the nature of public streets and sidewalks, both definitionally and regarding the rights that pedestrians have while using those streets and sidewalks. The pending decision from the Court of Appeals has the potential to deeply inform a variety of future cases.

ESSAYS/PERSONAL STATEMENTS

29. What are your reasons for seeking this position? (150 words or less)

Many local judges believe they simply don't have to follow the law. They know their word is final in nearly all cases, so they rule however they want and do their best to cobble together legal reasoning that would arguably support their decisions. They hide behind judicial immunity and the byzantine appellate process, imposing their version of morality rather than the law. For some judges, this is simply incompetence, as they lack the ability to understand complicated legal issues. In worst case scenarios, judges abuse their authority by using it to target those who have irked them. I have a special talent for ferreting out legal nuance, combined with a deep respect for the law—especially constitutional principles. These traits make me particularly fit for the judiciary. Providing consistent, diligent, and lawful rulings as Criminal Court Judge is the best and most impactful way that I could serve Davidson County.

30. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking appointment to the Criminal Court of Davidson County, in the 20th Judicial District, in Nashville. I would be working in an individual capacity assigned to a specific courtroom, doing 100% criminal law. My commitments would be to fairness, transparency. and upholding the rule of law. One impact I hope to have is creating respect for the jurisdictional boundaries of Criminal Court. The appellate caselaw is clear that bindover from General Sessions only gives Criminal Court jurisdiction over bond; an indictment or information is required for Criminal Court to receive plenary jurisdiction. As it stands, the Court Clerks send all motions after bindover to Criminal Court, even those for which General Sessions retains jurisdiction. This is illegal and significantly impacts rights, especially given that it is taking approximately 6 to 9 months for bound-over cases to be indicted. As Judge, I would respect the limits of judicial authority.

31. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. I am a strong supporter of forming beliefs based on reasons. One manifestation of that is trust in evidence-based conclusions, especially those produced by following the scientific method. Accordingly, my wife and I have vaccinated our children as recommended by their pediatrician. We regularly get flu shots and got the COVID-19 vaccine as soon as it was available after being proven safe and effective. Nonetheless, I was once appointed to represent an anti-vax mother whose child was in DCS custody and who wanted to keep her child from being vaccinated. As a tireless advocate for children's welfare, I vehemently disagree with this decision. Moreover, I strongly oppose the TN law allowing parents to refuse to vaccinate their children on religious grounds: I believe vaccinations should be mandatory for every child unless medically contraindicated. In the case at hand, however, my client's position was that her religion opposed abortion and vaccines are made from aborted fetuses, so she had a religious objection to vaccination. Despite both my personal distaste for this particular piece of advocacy and the fact that vaccines are not actually made from aborted fetuses, I obtained an order from a Magistrate prohibiting DCS from vaccinating my client's child. My obligation was to the client and her wishes, not to the child or what I want the law to be. As a judge, similarly, I would respect the law as required by Tennessee and United States jurisprudence.
