I am currently employed as a solo practitioner with the Law Office of Kyle D. Parks, Esq. I have been practicing in this capacity largely since 2009. In 2018 I was unanimously appointed as Davidson County Night Court Judicial Magistrate by the General Sessions Judges of Davidson County. I have continued to serve in both positions, solo practitioner and Davidson County since my 2018 appointment except for the time frame from 2021-2022 when I resigned to run for this subject bench when I lost against Judge Cheryl Blackburn who held the bench for over two decades.

I started my career as an associate attorney for the Law Offices of Luvell Glanton. (2009-2010) From Mr. Glanton's office, I opened my own firm, the Law offices of Kyle D. Parks, Esq. (2010-2013). I briefly worked as an associate attorney at MANSON JOHNSON (2013-2017) and was promoted to Partner in 2015. In 2017, I left Manson Johnson to reopen my own office where I have been self-employed since 2017. In 2018 I was unanimously appointed as Night Court Magistrate by the General Session Judges of Davidson County). Only have practiced as a Criminal Defense attorney other than my judicial position with night court.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My practice is 100% criminal defense and has been solely devoted to criminal law since 2010. I built my practice through accepting pro bono cases to support my caseload. In recent years, my private practice has lowered the number of appointed cases I am able to accept. I have practiced as a Criminal Defense practitioner in 66 of Tennessee's 95 Counties, State Court only. In my professional capacity as a licensed attorney, I have handled criminal cases either as a lawyer or judicial officer from every material point in the life cycle of a case post arrest. In this practice, I have handled criminal cases from arrest, to jury trial, to appeal and to successfully arguing to the Criminal Court of Appeals a denied petition for post-conviction relief by the trial judge.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

As stated above, my large majority of my legal experience and work has been in the criminal law context, both as a lawyer and judicial officer. I have limited my practice to just State level Court. Initially, I started working at a civil law firm handling personal injury matters. I quicky realized that civil law and no other law for that matter was as interesting to me as Criminal law. From that decision until today, I have enjoyed the fruits of my very focused labor and have run a successful law practice while serving the County as a night court judicial magistrate giving me the broad experience that helps me daily in my pursuit of Justice. I believe my experience as a defense attorney and judicial magistrate give me a unique perspective that book ends with my involvement on the determining of probable cause to successfully arguing an appeal of a Post Conviction. I have an intimate look at the pulse of this County that will guide my pursuit of justice for every person who appears before the Court. There are some judges and candidates presiding that previously served as defense lawyers. There are others who only have worked for the State as prosecutors or law enforcement. The candidates who historically have been considered best qualified have handled both defense and prosecution or have served as a General Sessions judge. My unique experience, on the daily basis, requires me to remain focused to my opinion and approach to pursuing justice as my job as magistrate requires me to remain neutral

and detached. My law practice requires on a daily basis for me to understand the realities of what happens in our Courts, who are Defendants are in the current time and what they and alleged victims, citizens face daily with life and in the Courts. It all would amount to a very grounded and realistic bench, reinforcing the idea of steadiness and evenness associated with due process and fundamental fairness as guaranteed by both our State and Federal Constitutions.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

There are two matters of special interest that immediately come to mind. The first case has grown with me since 2012 and I attribute a lot of my professional maturity and growth to this Case, the Defendant and his family. I first came to be acquainted with this Case through my colleague and Firm mate. It is his nephew. As a new lawyer, he was prepared to go to Court and represent his nephew in this Post Conviction matter; I went along with him to guide him. I immediately recognized the complex legal issue the case would involve and felt that his experience wasn't what was needed. I accepted the appointment from Judge Randall Wyatt as the Post Conviction Counsel in 2012. That case is now solely Pro Bono and has been pending, with movement back and forth from the Appellate Courts to the trial Courts from my work. This was a widely covered case at the Trial level and involved the convictions of Defendants who were Juveniles at the time of the offenses that led to the death of the victim. The timeline and relevant events are as follows: The first hearing for post-conviction was completed in May 2017. After the initial denial, we appealed to the Criminal Court of Appeals and the attorney general agreed that Mr. Buford should have first filed a Rule 11 petition with the Supreme Court before starting his post-conviction process. After the denial of the Rule 11 petition we then had to restart the post-conviction process in trial court which was heard in October of 2023. After denial of the petition we again filed with the Criminal Court of Appeals and oral arguments are currently set for August 13, 2025.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

The second matter discussed above, I will discuss here for clarity and organization. The Second matter involved my pro bono work that led to, from what I understand from other clients and current potential, incarcerated clients, is a case that was appealed based on the novel argument at the trial court regarding merging offenses, jury instructions on what constitutes the same or separate offense. The Case was reviewed by the Appellate Court as State of Tennessee v. Christopher Lee Williams, No. M2016-00568-CCA-R3-CD. I sat second chair to my then firm mate who asked for my support due to the complexity of issues. After day two of proof, we realized the issue with the State's proof and strategy. We parted at 5PM with a divide and conquer plan. I researched and briefed overnight and effectively argued the Motion in our move for directed verdict. To this day, I am randomly stopped and encouraged by other defense attorneys or litigants when they learn who I am. It has been shocking to know how many people understood and used the arguments created by me in their practice and/or pursuit for their

I have remained at that post since 2018 with the exception of the time period in which I left to run my campaign for this same position.

28. What are your reasons for seeking this position? (150 words or less)

It is important that everyone is truly heard when their lives, freedom, and safety are at stake. My life, my family also provides me a layer of understanding and compassion that I believe will benefit the Bar (both Defense lawyers and State Lawyers), Defendants, and Victims. All 3 of my children appear on the spectrum for autism from high functioning to nonspeaking. This can make communication and simple interactions challenging. At times, my children are unable to fully express themselves and they can become very frustrated. This causes them to act out without warning and unable to convey what's affecting them. At times of high emotional stress it is important to not let your own emotions add to the conflict or prevent you from finding a

way to deescalate. This pause in judgment and the need to assess before reflexively making a decision that can make a bad situation worse.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

Criminal Court-Division III The docket is entirely criminal cases and serves all of Davidson County. As State Trial Court Judge, my job is to follow the law, not make new law or change laws that I do not like so my impact SHOULD be gradual and not sudden. However, the impact that I anticipate may be more expediate will be related to and connected to my unique broad and well-rounded perspective ascertained from my in-depth experience as a Criminal law practitioner and magistrate. I have materially handled every part of the Criminal Court case life cycle besides the investigation and arrest. This well-rounded perspective gives me more to consider and allows me to be more relatable to all involved, Defendants, Victims, law enforcements, and family. Court will always be overwhelming and intimidating to non-lawyers, but my impact will make it a little less contentious.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

As Night Court Magistrate, I have a close and unique insight into the severity and seriousness of Domestic Violence in Davidson County and understand how devastating it can be on families for generations. My decisions impact that. Defendants' prior convictions, under law, is used as a factor for setting bond amounts and conditions. These conditions and amounts again, are immediately impactful on the Defendant, victims, and their loved ones; these conditions can sometimes thrust Defendants into a cycle of indigency that materially impacts their ability to defend themselves or even recover if the allegations are indeed false or made from levity, which unfortunately sometimes happen. Notwithstanding all the above, in many situations, I have encountered Defendants, who are legally innocent of the crime, have multiple, cyclical and almost predictive arrests concerning the same alleged victim. I am able to see the arrest and the prior cases related to the Parties and most if not, all are often dismissed. The alleged victim doesn't show for Court, and the Case are dismissed. When considering bond amounts and conditions I am not able to consider the prior arrests in setting the bond amounts even when the patterns suggest there is cause of concern. The law prohibits it.
