6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I exclusively practice criminal law. I am currently the Team Leader of the Crimes Against Children Division ("CAC") of the Nashville District Attorney's Office. This team consists of thirteen professionals, including seven experienced prosecutors and three criminal investigators.

I oversee the investigation and prosecution of crimes involving child victims. This includes prosecution of child death and cases where a child has been physically or sexually abused, neglected, or endangered. CAC also prosecutes internet crimes against children such as solicitation of a minor, revenge porn, and the creation, distribution, and sell of child sexual abuse material.

Although I am primarily a trial attorney, as CAC Team Leader I also collaborate with key stakeholders within Davidson County to ensure that crimes against children are effectively tracked and prevented when possible. For example, I regularly meet with leaders and advocates working to investigate and prevent child abuse such as the Davidson County Child Death Review Panel and the leadership for partner members of the Child Protective Investigation Team. The purpose of these meetings is to foster collaboration, develop systematic changes, and implement best practices.

Additionally, I routinely advise child abuse detectives at the Metropolitan Nashville Police Department on charging decisions during active investigations. This requires me to analyze whether a judge or grand jury, from a position of neutrality, will find probable cause when applying the law to the facts presented.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have been a trial attorney since I began my career at the State Attorney's Office in Miami, FL. After training, I asked to be placed in the Domestic Violence Unit. After approximately a dozen jury trials, I was elevated to the Juvenile Court team where I handled all cases in which a juvenile had been charged with a misdemeanor or a felony. Next, I prosecuted serious felonies involving adults in criminal court. I also served on the Human Trafficking Task Force before being selected for assignment in the highly competitive Public Corruption Unit where I was part of a task force that conducted proactive investigations and prosecutions of public officials.

I left the State Attorney's Office in 2017 to join the Office of the District Attorney General in Nashville. I was assigned to the Crimes Against Children division shortly after joining the office. I have also been assigned to Criminal Court Division III – the same court for which I am applying to fill a judicial vacancy. In 2022, I was selected to be Team Leader of the Domestic Violence Division, and, in 2023, I became Team Leader of the Crimes Against Children Division. I have held the latter position since then.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

Before I ever met an attorney, I daydreamed of being in a courtroom as a child in the outfield at my baseball games. As a young person, I witnessed others around me suffer from injustice. Some had been victims who were left disheartened by their offender's lack of accountability. Others were defendants who received unduly harsh treatment despite their potential for rehabilitation. In these instances, the judicial system failed to meet the needs of the community. This happens far too often.

During my career, I have tried my best to be judicious in the application of law, balancing toughness with empathy. I will continue to strike this balance as a judge by thoughtfully applying the law to the facts and clearly explaining my decisions so that all parties will know they are being treated fairly. I believe this instills faith in our system and thereby makes our community safer.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am applying to fill the vacancy in the Criminal Court for the 20th Judicial District, Division III. The court presides over criminal matters in Davidson County, Tennessee.

Nashville is my home by birth and by choice. I went to law school with the plan to become a public defender in Nashville but graduating during a recession led me to Miami where I found a great sense of purpose in fighting for victims. I moved back to Nashville because I wanted my hard work and sense of justice to benefit my hometown. Our system demands that judges account for a victim's harms as well as the mitigating circumstances that led a defendant to criminal activity. I will bring my professional experiences and perspective with me to the bench so defendants, lawyers, victims, and constituents leave knowing that Division III is a place where the law is fairly applied.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I will. As an Assistant State Attorney in Miami, I prosecuted an elderly lady with no history who had been arrested for delivering heroin. The charge carried a 15-year mandatory minimum prison sentence. The law did not permit the judge to exercise discretion in sentencing. At the time there was insufficient evidence to charge her grandson, who was the investigation's target. She had willingly participated in the conspiracy and refused to cooperate against any of her co-conspirators. It was difficult to send this grandmother, who looked much like my own, to prison for such a long time but it was mandated by law. So, I followed the law and it was the right thing to do.

As another example, in the Nashville District Attorney's Office I prosecuted a defendant with a very violent history for committing homicide. Just weeks before the trial the only eyewitness, an innocent bystander, told me through tears that she would not testify out of fear. She was a single mom who lived in the same impoverished neighborhood as the defendant. There was no option to provide her with real safety or protection against retaliation. Instead, upon my request the judge issued a material witness warrant requiring her to be taken into custody until she testified. Because I forced her to tell the jury the truth, the defendant was found guilty and is now serving a life sentence. The witness was not happy, but she thanked me when she learned of the verdict.
