28. What are your reasons for seeking this position? (150 words or less)

When I decided to go to law school, it was for the ultimate purpose of serving as a judge. I have both a passion for the law and a desire to serve others. My experience litigating and mediating has provided me the skills to navigate the complexities of the courtroom and the expectation of litigants, and my time spent in a large department within state government has strengthened my resolve to serve in my hometown of Chattanooga to the best of my ability. I want to focus on treating each attorney, litigant, and witness with the respect and patience they deserve whether they are in court once a day or once in their lives.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking the 11th Judicial District Circuit Court Judgeship. While this Court hears many types of cases, including civil torts, worker's compensation claims, and contract disputes, domestic relations cases represent the majority of litigated cases. I have extensive experience in domestic relations litigation, and my position in the second division would complement the three additional judges and their experience and areas of expertise.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I served as an attorney for a gentleman who had litigated for many years in a different county with a different attorney. After beginning my representation of him, it was discovered that the order transferring jurisdiction from the previous county was void of the necessary findings and reference to the applicable statute, rendering the current court without proper jurisdiction. Despite years of litigation and tens of thousands of dollars spent previously, it was appropriate for me to agree with an order sending the case back to the previous county for proper transfer, potentially nullifying the progress my client had made in this county. While I disagreed from a fairness perspective that a mere technicality should void all of his progress, I was bound to follow the law and practice within its parameters. Similarly, should I have the honor of being appointed as a judge in Hamilton County Circuit Court, I would continue to uphold the law even if I disagreed with the substance of the law at issue.
