**ORDER**

Upon consideration of the Tenn. R. App. P. 11 application for permission to appeal filed by Corey Adams, and the record before us, the application is granted and remanded to the Court of Appeals for further proceedings consistent with this order.

The Court of Appeals' opinion did not address the first issue set out in Mr. Adams' brief filed in the intermediate appellate court. As stated in the brief, that issue was: "The Chancery Court improperly dismissed the appellant's writ of certiorari without first disposing of his pretrial motions." For that reason, the Court grants Mr. Adams' application for permission to appeal and summarily remands the case to the Court of Appeals for that court's consideration of the omitted issue. Additionally, we note that the brief filed in the Court of Appeals on behalf of the respondents did not address Mr. Adams' first issue. The Court of Appeals may order the parties to file supplemental briefs on the issue.

**ORDER**

On January 24, 2014, the Court of Appeals dismissed Gursheel Dhillon’s Tenn. R. App. P. 3 appeal for failure to pay the litigation tax within ten days of the show cause order of January 7, 2014. On March 24, 2014, Mr. Dhillon filed in this Court a Tenn. R. App. P. 10 application for an extraordinary appeal seeking reinstatement of his Rule 3 appeal on the ground that he has now paid the litigation tax. Because the order dismissing the Rule 3 appeal is a final decision of the Court of Appeals, Mr. Dhillon’s Rule 10 application has been treated as a Tenn. R. App. P. 11 application for permission to appeal. Upon consideration of Mr.

Dhillon’s application and the record before us, the application is granted and the case is summarily remanded to the Court of Appeals for that court’s consideration of whether the Rule 3 appeal should be reinstated.

Mr. Dhillon also seeks review under Tenn. Sup. Ct. R. 10B of the trial judge’s denial of a recusal motion.

The appropriate appellate court for review is the Court of Appeals. *See* Tenn. Sup. Ct. R. 10B, § 2.02 (stating that the appropriate appellate court for review is “the appellate court to which an appeal would lie from the trial court’s final judgment in the case”). Accordingly, the Rule 10B appeal is transferred to the Court of Appeals. *See* Tenn. R. App. P. 17.

Finally, Mr. Dhillon states that he “believes recusal of Judge Cornelia Clark should be considered.” The basis for recusal appears to be that Justice Clark and the trial judge, whom she appointed, are past members of the Williamson County Judiciary. Mr. Dhillon’s assertions fail to comply with the procedural requirements for a recusal motion. *See* Tenn. Sup. Ct. R. 10B, § 1.01. Justice Clark has nonetheless considered the request for recusal and denies it on the grounds stated in *Gursheel S. Dhillon, M.D. v. State of Tennessee Health Related Boards, Et Al.*, No. M2012-02431-SC-OT-CV (Dec. 11, 2012).
