**ORDER**

Upon consideration of the application for permission to appeal of Sharondra E. Harris and the record before us, the application is granted.

In addition to the issues stated in the Application for Permission to Appeal, the Court directs the parties to address in their respective briefs and at oral argument the following issues:

1. Whether Mae L. Chearis or her estate had standing to challenge the “Stipulated Agreement of Support and Admission of Paternity” and the related order of the Chancery Court of DeSoto County, Mississippi approving that Agreement under Tenn. Code Ann. § 24-7-113(e).

2. Whether, based upon the record on appeal, the trial court properly denied the motion for relief from the settlement and order of dismissal pursuant to Tenn. R. Civ. P. 60.02(3) and Tenn. R. Civ. P. 60.02(5).

The Clerk is directed to place this matter on the docket for oral argument upon the completion of briefing.
