Statewide Appellate and Trial Court Statistics

This section is the statistical portion of the Annual Report of the Tennessee Judiciary for fiscal year 2003-04. Included in this report is information gathered from the offices of the Appellate Court Clerk in Nashville, Knoxville and Jackson and the state clerks of court in Tennessee. The collection of this information is mandated by the Tennessee General Assembly and is used primarily as a tool to measure the effectiveness of the court system in Tennessee. The report is divided into three major sections: appellate (Supreme Court, Court of Appeals and Court

of Criminal Appeals) caseload data; state trial court (chancery, circuit and criminal) filings and dispositions data; and jury and non-jury damages and torts data. The state trial court information is being reported by judicial district. All information disseminated in this report has been distributed to and verified by the judges and clerks of court of their respective judicial districts. 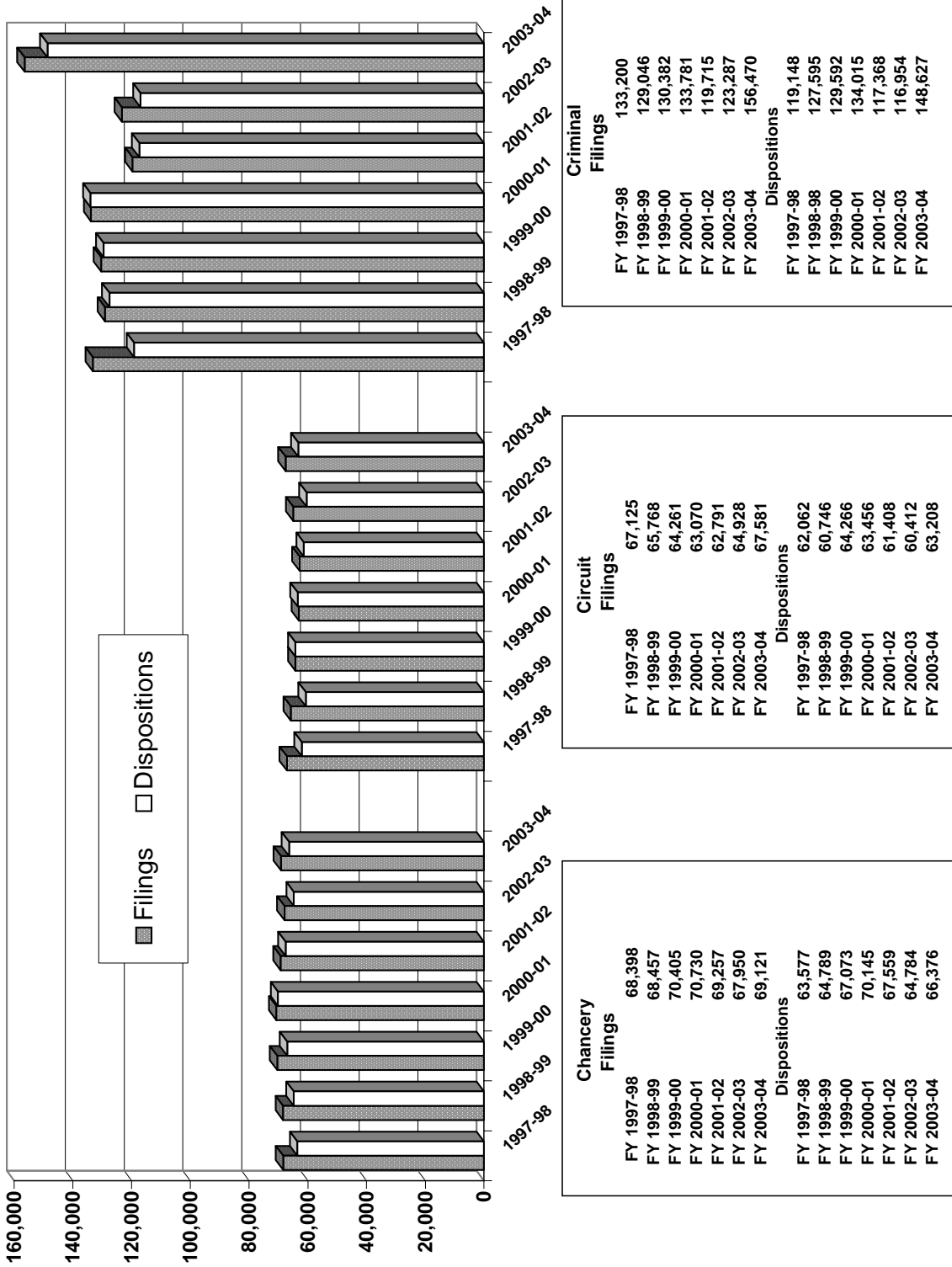

Damages and Torts Cases

Fiscal Year 2003-04

Effective July 1, 1989, Tennessee Code Annotated, §16-21-111, requires the clerk of each Circuit Court and the clerk and master of each Chancery Court to report to the Tennessee Judicial Council the following information on a monthly basis: the number of cases filed claiming monetary damages for personal injury or death, and the number of such cases actually proceeding to trial. For those cases proceeding to trial, clerks must also report:

- the number of cases in which the plaintiff was awarded monetary damages for personal injury or death;
- the amount of judgment in a jury case;
- the amount of judgment in a case without a jury;
- any additur or remittitur awarded in the case by the trial judge.

The staff of the Administrative Office of the Courts (AOC) must compile this information and report the findings of the previous fiscal year to the chairpersons of the Senate and House Judiciary Committees and to the Attorney General.

Pursuant to this code section, the AOC, acting as staff for the Judicial Council, prepared this report. Beginning in fiscal year 1995-96, this report was incorporated into the *Annual Report of the Judiciary* so that statistical information on the court system could be easily located.

The clerk of each Circuit Court and clerk and master of each Chancery Court send monthly reports on all case filings and dispositions to the AOC. Case filings are classified by case type categories, one of which is damages and torts. The damage and torts category consists of personal injury and wrongful death cases only. Property damage cases are reported under the

Miscellaneous General Civil category. Dispositions are classified according to the manner in which the case is disposed. For the purpose of this report, the disposition categories used were jury and non-jury trials. Also reported is whether or not monetary damages were awarded and the amount awarded, if any, and the amount of any additurs and remittiturs to the original awards. This data is contained on the Tennessee Judicial Information System (TJIS) database.

Information gathered from the TJIS database provides the basis for the analyses included in this report. The following charts and graphs include cases that meet the following criteria:

- the case involved a claim for monetary damages for personal injury or death;
- the case was disposed of during the July 1, 2003 – June 30, 2004, time period;
- the case went to trial;
- the case was not settled or dismissed.

Prior to the publication of this report the AOC staff mailed preliminary data sheets to each Circuit Court clerk and to each clerk and master. Each was asked to review the information for accuracy - specifically taking into consideration the criteria described above - and to submit corrections if necessary. Copies of the data sheets also were sent to each judge in their respective districts.

Overall, for fiscal year 2003-04, data reported as to damages and torts cases showed a small increase in the number of filings and a very slight decrease in the number of dispositions reported over last fiscal year. There were 13,192 filings and 12,004 dispositions for fiscal year 2003-04. Damages and torts cases represented 9.46 percent of civil filings and dispositions for the

fiscal year. Of the 12,004 damages and torts cases disposed of during the year, 625 (slightly over 5 percent) proceeded to trial. Jury trials accounted for 347 (56 percent) and non-jury trials for 278 cases (44 percent) of the cases that proceeded to trial. There was a decrease in the number of cases going to trial over those reported last year. The four metropolitan areas (Davidson, Hamilton, Knox and Shelby Counties) had 270 damages and torts cases (43 percent) going to trial. The four metropolitan counties accounted for 37 percent of all civil filings and dispositions for the year. The chart on page 149 has a comparison breakdown of damages and torts cases disposed of and cases going to trial from fiscal years 1994-95 through 2003-04.

Of the 625 cases going to trial in fiscal year 2003-04, 292 were awarded damages. The statewide total for damages awarded is \$41,030,956, which is an increase of \$408,982 reported for the previous fiscal year.

The four metropolitan areas reported \$17,682,209 in damages awarded for this fiscal year, which is \$7,765,656 more than was reported for these areas last year. The four metropolitan areas' total damages awarded represents 43 percent of all damages awarded. The chart on page 150 shows total monetary damages for fiscal years 1994-95 through 2003-04.

The average award for fiscal year 2003-04 was \$140,517. This represents an increase of \$20,688 from the previous year. The chart on page 150 gives the average monetary award for fiscal years 1994-95 through 2003-04.

Wilson County had the largest award for fiscal year 2003-04 at \$8,000,000. There were 18 awards of \$500,000 or more for a total of \$29,278,185. This represents 71 percent of all damages awarded. Eight of the 18 cases were for \$1 million or more for a total of \$22,324,851. A brief synopsis of the case with the largest award follows.

Largest Award

The largest award for fiscal year 2003-04, \$8,000,000, was a personal injury suit filed in Wilson County Circuit Court on March 29, 1999. The following information was obtained from the Wilson County Circuit Court Clerk's Office. The plaintiff, Cathy Pitts, filed a complaint against Floyd Wilson, Jr. stating that on April 5, 1998, the defendant with force and violence willfully, maliciously and intentionally assaulted the plaintiff by firing numerous shots from an SKS 7.62 semi-automatic assault rifle into a residence in which the plaintiff was a guest, striking the plaintiff in the leg, causing the plaintiff to suffer extensive, painful, debilitating and permanent damage.

The plaintiff made several allegations against the defendant, including the following:

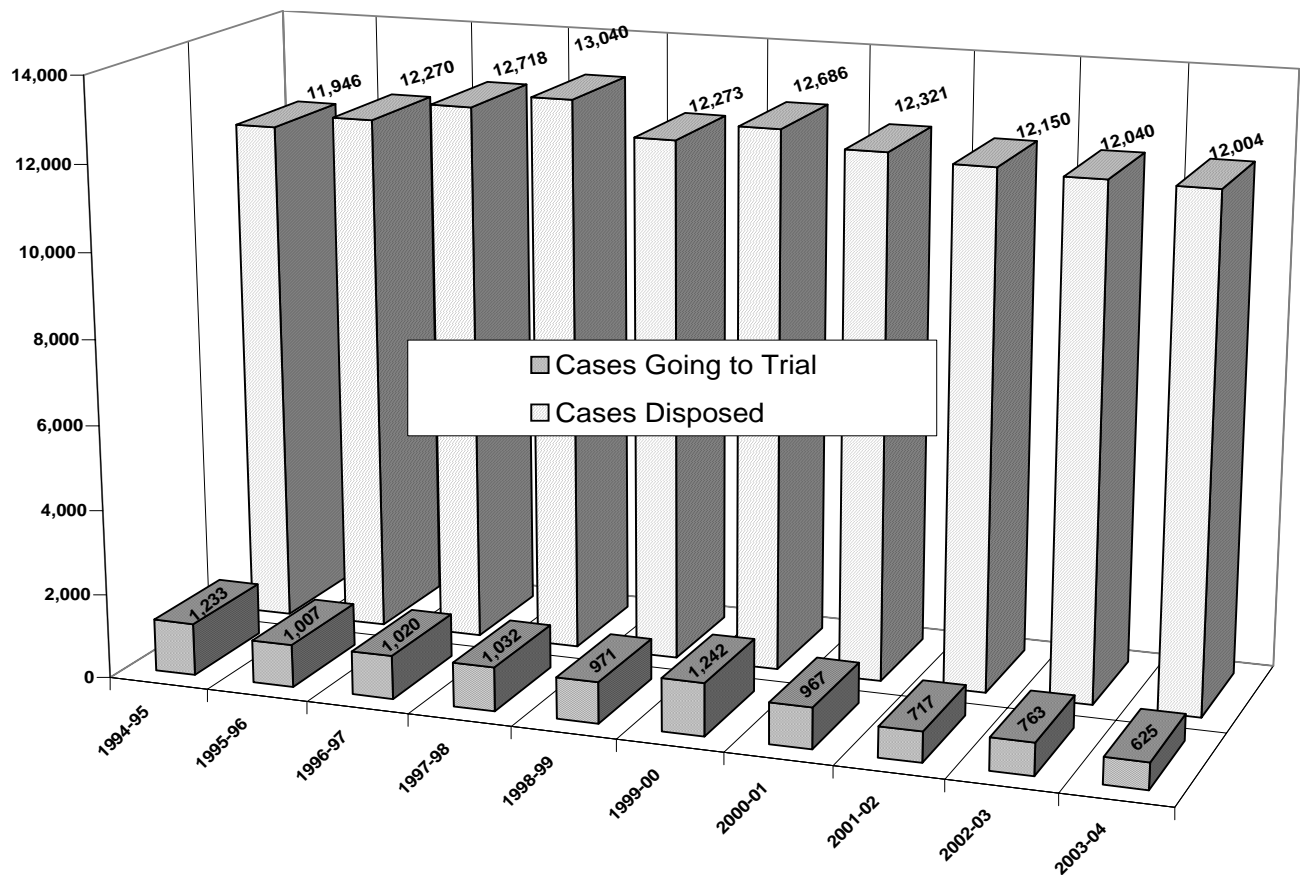
- actions were performed with knowledge of the inherent danger, lack of safety and likelihood to cause injury to a third person; and
- actions were willful, wanton, malicious and undertaken with reckless disregard.

This cause came to be heard on February 27, 2004, as a bench trial, before the Honorable John D. Wooten, Jr. Upon a review of all the facts and testimony of the parties and witnesses presented, the court found in favor of the plaintiff and awarded the plaintiff the sum of \$8,000,000 dollars (\$2,000,000 compensatory; \$6,000,000 punitive). (Cathy Pitts Crowder v. Floyd Wilson, Jr., a/k/a Buddy Wilson, docket number 10770).

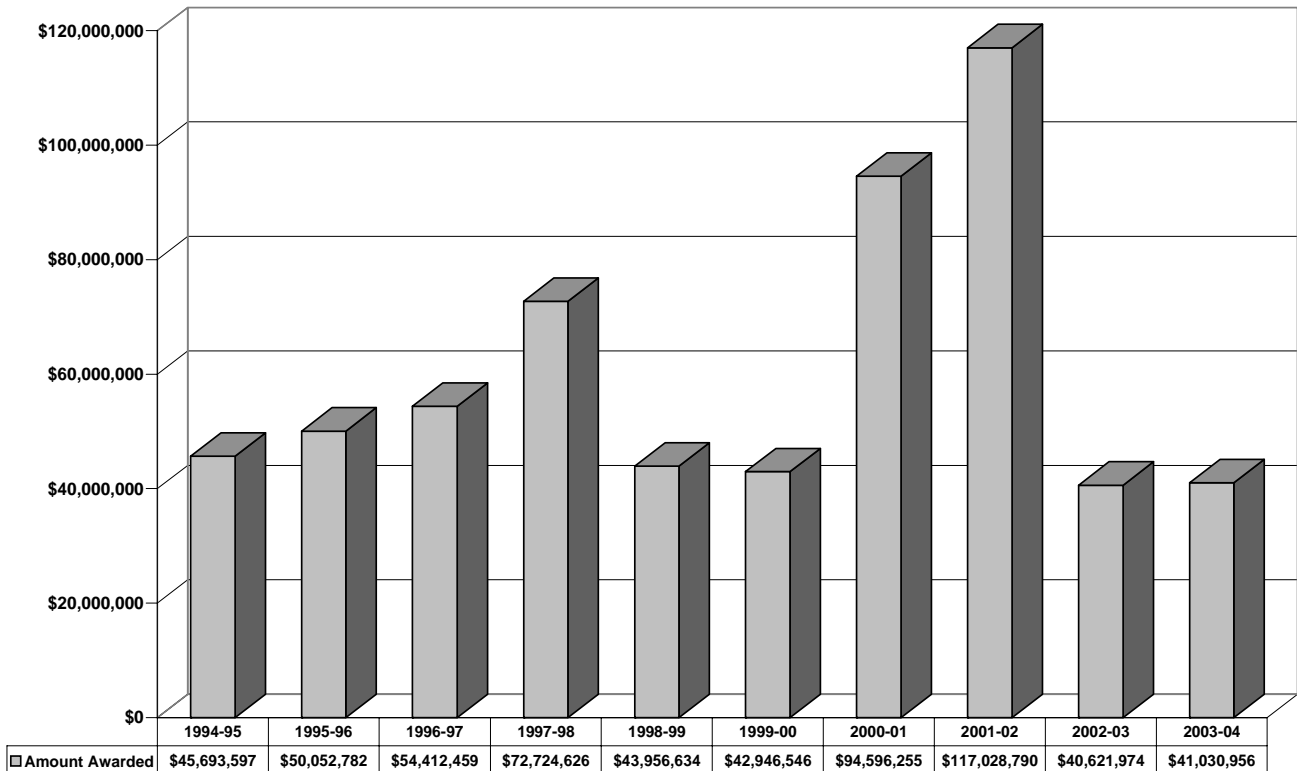

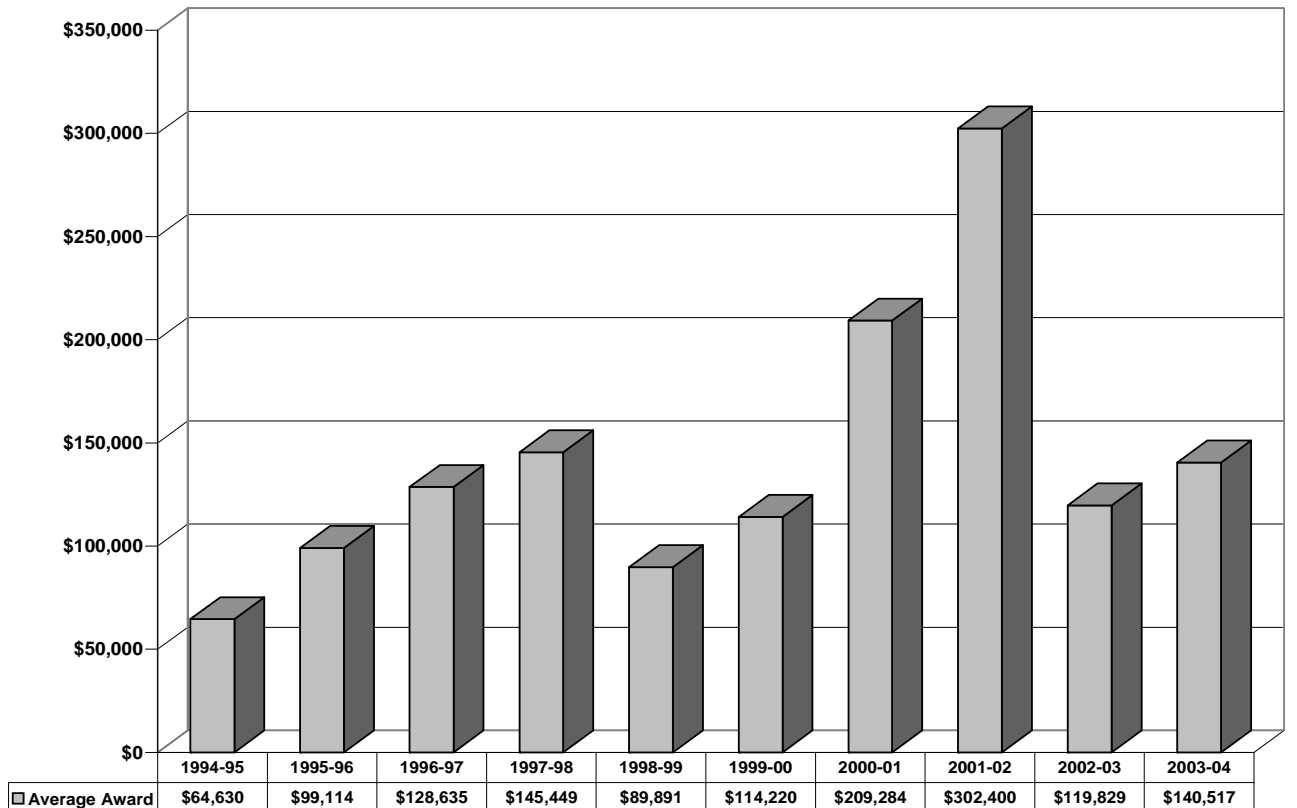
Damages and Torts Cases Disposed Statewide Fiscal Years 1994-95 Through 2003-04
