Criminal Law practice is approximately 60% of my business with Domestic/Divorce Law making up the other 40% of my practice. I have handled every type of criminal matter from DUI cases to Murder trials in the last 19 years.

I have represented clients ranging from DUI and Drugs to Assault, Murder and Rape through General Sessions Court to the Court of Criminal Appeals. Additionally, my divorce practice has ranged from simple divorce to complex divorces dealing with multiple businesses and streams of income. Included in that practice I have represented clients on Custodial issues and trials along with visitation modifications.

I have sat as Special Judge in the General Sessions courts of Rutherford County, Tennessee on numerous occasions in the last 19 years.

I have handled Rape Jury Trials, Murder Jury Trials, Drug Jury Trials and Divorce Bench Trials dealing with Custody, Spousal Support, Relocation, Distribution of Assets, Father's Rights, and Modifications of divorce decrees. I have in several of the Murder/Rape trials followed those matters to the Court of Criminal Appeals by drafting and arguing the Motions for New Trial and Post-Conviction Relief.

I worked as Paralegal/Investigator with the State of Tennessee Attorney General's Office in Nashville from 2000 until I opened my practice in October 2004. I worked with the Tobacco Division during the negotiations and settlement of those actions and distribution of monies. Further, I was tasked with identifying and bringing actions against individuals and businesses in the State of Tennessee related to the price gouging that followed the September 11 attacks in 2001. In this position I worked with many different divisions of the Tennessee State government from Charitable Organizations, Consumer Protection Division, Tennessee Board of Law Examiners and the Governor's Office.

I am seeking this position because I believe that the Rutherford County Bench is one of the best in the State. For the last nineteen years I have built a successful practice in Rutherford County, Tennessee focusing primarily on Criminal and Domestic law. I have been goal oriented and task driven from an early age with the ability to set goals and work tirelessly to achieve those goals. I have built a successful trial practice since opening my office in 2004. Upon graduating from law school my objective was to try as many cases as possible in front of juries and judges of Rutherford County. The next natural evolution for me is to transition to Judge to continue my long standing commitment to the citizens of Rutherford County, Tennessee. I have a laid back demeanor and cannot be outworked by anyone.

I am seeking appointment to the Circuit Court Judgeship in Rutherford and Cannon County, Tennessee. This position will oversee a variety of cases from Divorce to Medical Malpractice cases. Currently, there are six Circuit Court Judges in the judicial district. The vast majority of the cases handled by these positions are divorce or divorce related in some way. My selection to Court will bring 19 years of experience in divorce and family law with a mixture of various civil matters I have handled in my career. In the process of building a successful practice I have handled numerous divorce, custody, custody modification, relocation, spousal support and asset identification and distribution trials in the last nineteen years. Additionally, I have tried numerous murder, rape, assault, drug and DUI cases before juries of Rutherford County. My strong work ethic and experience make me an excellent choice for the Judgeship.

Yes. It is the duty of the presiding judge to uphold any duly enacted laws or rules of this State without regard for his/her personal opinion on that law. One current interest is a relatively new statute enacted wherein police officers are able to seize weapons of individuals they believe to be under the influence of alcohol or narcotics. This particular statute has recently come into play where a client was visiting friends at a party and walked out to speak with the friends. Officers approached and claimed to smell marijuana. They searched all four parties finding marijuana on two other individuals and guns in their vehicle. Police searched my clients' vehicle and found his legally owned handgun. Police seized that handgun and charged my client with Possession of a handgun while under the influence. There was absolutely no proof that my client had been smoking marijuana and one of the officer's testified that he had seen my client leave the house and walk over to the group just minutes before the officers made contact. Simply because my client had been in the area where the other individuals were smoking marijuana he was, his vehicle was searched and he was arrested for possession of handgun under the influence. This particular statute does not explain or detail what exactly is meant' by "Under the Influence" leaving this subjective analysis to the individual officer. This statute requires no Field Sobriety Tests or bloodwork for an individual to be deemed "Under the Influence".
