As an Assistant Public Defender, I am currently restricted by statute to representing criminal defense clients to whom I am appointed by the courts of Sumner County.

During my years in private practice, family law and criminal defense were the majority of my case load. I also successfully represented clients in areas of trademark/copyright, conservatorships, trade secret litigation, disability discrimination, corporate dissolution, and juvenile delinquent/unruly and dependent/neglected cases. My overall experience included trial courts, general sessions courts, and appellate courts, in the counties of Sumner, Davidson, Rutherford, Robertson, and Dickson. My family law practice included divorces, post-divorce proceedings, custody disputes, termination/adoptions, and paternity matters. My criminal defense experience runs the gamut from simple misdemeanors, to child rape, aggravated robbery, and first-degree murder.

I was honored to sit as a Special Judge for the late General Sessions Judge Mike Carter in Sumner County. I won my first jury trial after the jury deliberated for only 20 minutes. I have created novel legal concepts that allowed cases to be resolved to the satisfaction of both parties, particularly in the area of criminal law.

I have been a Rule 31 listed mediator in General Civil, Family, and Domestic Violence, since 2017, and was proud to successfully mediate family law and estate cases. I also participated as a Judge in a local Mock Trial Competition.

I believe I have received only 2 CAP letters (Consumer Assistance Program), and to the best of my knowledge they were dismissed as being without merit. I have not been able to get written confirmation from the BPR, but was advised that if I did not hear from them within 45 days of my response, I could consider the matters dismissed. CAP letters occur more often in appointed criminal cases and rarely, if ever, result in formal complaints.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

Since sitting as Special Judge for Mike Carter, I have wanted to be a judge. Analysis, dedication to the rule of law, and the ability to remain neutral and detached, are among my strongest attributes. My goals are to ensure parties in my court know they will be heard and treated fairly under the law, and that attorneys know the rules of the justice system will be adhered to.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking the new Circuit Court Judicial position in Sumner County. There are currently two Circuit Court judges in Sumner County (one civil, one criminal) and one Chancellor. According to the Chancellor, the new judgeship would likely be a hybrid of both criminal and family law cases, presumably to offset the increasing trial backlog in both circuit courts. My experience as a family law practitioner and criminal defense lawyer is ideally suited to assume this position. My experience in various other areas of law will also provide flexibility for caseload assignment. My desire and ability to be a good steward of the law of the State of Tennessee, to best serve my community, will ensure that whatever role is given to this judgeship will be fulfilled.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

There can be no other answer than yes. Variations of the word "impartial" appear in 3 of the 4 Canons of Judicial Conduct. Judges enforce the law impartially, as referees must. They cannot line-item veto laws they disagree with, nor can they create laws to suit their wishes.

I will not hesitate to uphold the laws of this State, even if I personally disagree with them.

In my current role as an advocate, the law obligates me to zealously advocate for all of my clients and maintain confidentiality. I did so even if a client verbally abused or insulted me, and I ensured that opposing counsel was unaware of their treatment of me.

Additionally, upholding the law begins with understanding it.

Criminal sentencing laws are complex and ever-changing. For example, mandatory consecutive sentence rules, statutory parole eligibility, mandatory fines/fees, no double-usage of pre-trial jail

credits on consecutive sentences, are all potentially detrimental to criminal defendants.

I have refused to convey settlement offers, demanded by clients, where the resulting disposition would violate sentencing laws to my client's benefit. I have reminded opposing counsel of these rules during plea negotiations, where settlement offers they made would violate those rules. I may disagree with these rules, especially in the role as a zealous advocate, but I still upheld them.

As a Judge, the role changes from advocate to referee, but the duty to follow applicable laws does not change.
