Since August 2011, I have been employed as Senior Judicial Law Clerk to The Honorable D. Kelly Thomas, Jr., on the Court of Criminal Appeals.

Prior to my present employment, I have worked sequentially in the following capacities: (1) Senior Judicial Law Clerk to The Honorable David H. Welles in Nashville from January 2006 to July 2011; (2) Staff Attorney for the Tennessee Department of Commerce and Insurance in Nashville from November 2004 to December 2005; (3) Senior Judicial Law Clerk to The Honorable David G. Hayes in Jackson July 2001 to November 2004; (4) Case Law Editor for Lexis-Nexis in Memphis from April 2001 to July 2001; and (5) Associate for Cordts Law Firm in Memphis from November 2000 to January 2001.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I am currently a State of Tennessee employee. Though the workload on the Court of Criminal Appeals deals exclusively with criminal jurisdiction, often quasi-civil matters are involved in the post-conviction forum. Cases reviewed by the Court of Criminal Appeals, and of which I have been personally involved, include: direct appeals in death penalty and all other cases, interlocutory appeals, post-conviction petitions, writs for habeas corpus, writs for error coram nobis, writs of certiorari, and Rule 36.1 motions.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

Over an almost nineteen-year period, I have worked extensively with three different judges on the Court of Criminal Appeals. During that time, I have been involved in the review of hundreds of jury trials, guilty pleas, and post-conviction matters, likely working on over one thousand cases. My duties in this capacity require me to complete the following: (1) effectively research legal issues in a variety of areas; (2) timely draft legal opinions, bench memorandums, and other court documents; (3) aptly and professionally assist in relations with other judges through a variety of communication methods; (4) with a strong grasp of the court's record-keeping system, competently communicate with the Appellate Court Clerk's Office; (5) thoroughly and thoughtfully analyze complex legal issues by examining the appellate record, briefs, and case law; (6) knowledgeably advise on a variety of issues; (7) providence guidance to new clerks; (8) efficiently supervise and educate interns; and (9) daily gain indispensable knowledge of rules of writing, legal citation, and proper Bluebook form.

Also, as part of my government service, I have worked as a Staff Attorney for the Department of Commerce and Insurance. While serving this administrative body, I was involved in the following activities: (1) researched legal issues in the areas of insurance, tax, securities, and administrative law; (2) drafted rules, manuals, pleadings, memorandums, orders, other legal documents, and legislative bill summaries; (3) provided legal advice to the financial affairs section regarding compliance with insurance laws, rules, and regulations; (4) examined insurance company financial statements for financial solvency; (5) evaluated insurance company information pertaining to admissions, premium taxes, examinations, third party administrators, and mergers and acquisitions; and (6) attended meetings with attorneys, department staff, and other interested parties.

Briefly, I was employed as a Case Law Editor for Lexis Nexis. In this capacity, I created case law summaries from opinions in the LEXIS database, preparing brief summaries of the important facts, rules, and holding of the case, following editorial guidelines. This job required analytical skills and the ability to rapidly produce thorough, accurate, and concise summaries. My experience with Lexis Nexis was an essential factor in Judge Hayes' decision to hire me to serve as his law clerk.

Finally, for a short time, I worked as an Associate for the Cordts Law Firm. This was a small law firm environment, which required self-motivation and quick learning. In this capacity, I interviewed potential clients regarding family law and bankruptcy issues, prepared legal documents, and attended courtroom proceedings. Given the extreme importance of these issues to the clients, I felt more oversight and practical solutions were needed.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I believe that my detailed legal experience in the section above reflects my personal involvement in all three of these arenas. In my humble opinion, this direct involvement in the trial courts, appellate courts, and an administrative body makes me uniquely prepared to take on the responsibilities of a trial court judge in Anderson County. Moreover, in my time with the appellate court, I have been able to see how good trial judges operate effectively and are able to make decisions accurately and quickly.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

In my third year as a Law Student at the University of Memphis, I served as a law clerk for The Honorable D'Army Bailey in the Shelby County Circuit Court. In this capacity, I was intimately involved with preparation of the motion docket, which included compiling and organizing the relevant case materials for Judge Bailey, as well as researching any pertinent legal issues.

I obtained my Juris Doctorate Degree in May 2000 from the University of Memphis School of Law. I graduated with 3.247/4.0 GPA and was ranked 23 out of 161 students, placing me in the top fourteen percent of my class. Honors bestowed upon me included being a recipient of the Law Alumni Scholarship; receiving the Dean's Award for Excellence and CALI Award in

Jurisprudence; and being placed among the Who's Who: American Law Students. My activities while a student at this institution included being an Articles Editor for the Tennessee Journal of Practice & Procedure; participating in the First-Year and Advanced Moot Court Competitions, as well as the Mock Trial Competition; being elected Third-Year Bar Governor for the Student Bar Association; and being a member of Phi Delta Phi and the Environmental Law Council.

In addition, while a law school student, I took a Criminal Law class through the University of Oklahoma during the summer of 1998. The course was taught at Queen's College, in Oxford, England. I received the requisite grade for this course for it to be recognized by the University of Memphis in furtherance of completing the necessary requirements for obtaining my JD.

I completed my undergraduate education over a four-year period at Christian Brothers University, which is also located in Memphis. In May 1997, I received a Bachelor of Arts degree in History with a 3.5/4.0 GPA, thereby earning a Magna Cum Laude designation. Honors bestowed upon me by this institution included being a recipient of the Plough Scholarship; receiving the National Dean's List Award; placement on the Dean's List from 1994 to 1997; serving as Treasurer for the Phi Alpha Theta organization; and being a member of the Honors Program. My activities as a collegiate included being a member of Zeta Tau Alpha Fraternity for all four years, as well as serving a one-year term of Historian/Reporter for the organization; and I was also a member of the Pre-Law Society.

While a student at CBU, I took two courses during the summer of 1996 at Shelby State Community College in Memphis. I received the requisite grade for these courses for them to be recognized by CBU in furtherance of completing the necessary requirements for obtaining my BA.

Given my first husband's terminal illness (he suffered from amyotrophic lateral sclerosis), I have not been able to be involved in as many community activities as I would have liked. His illness not only required me to provide his care, but I also had to advocate for him and ultimately be his voice to deal with the insurance companies and assist in getting needed healthcare. I do, however, plan to be very involved in the community in future.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

I have served as a dedicated government employee for twenty years and endeavor to continue with public service. I believe that through my experience, I am uniquely qualified to fulfill this role. Most of my career has been committed to the process of adjudicating and formulating decisions on disputed matters, the precise business of trial court judges. Research and logical reasoning have been crucial.

I also believe that our life experiences shape us into competent, considerate, and compassionate people. My husband was diagnosed with ALS at thirty-nine and died three years later. To say such an experience was trying would do it a disservice. However, going through that will allow me to understand what people are feeling when in court. Also, it required extreme perseverance,

caretaking, patience, kindness, love, and dedication, as well as support from others. I will strive to bring these qualities with me to the bench.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I seek to serve the people of Anderson County as Circuit Court Judge, hearing both civil and criminal cases and appeals from lower tribunals. The County is considered part of the Norris Highlands. Judgeships in this District include one Circuit Court Judge (this specific vacancy), Chancery Court Judge, Juvenile Court Judge, and two General Sessions Judges, who serve the County's approximate 77,000 citizens. I have lived in Anderson County for almost ten years, residing in both Oak Ridge and Clinton. The kind and service-oriented citizens of Anderson County supported me throughout my husband's illness; they deserve an orderly and safe community in which to live. I believe my previous government service will allow me to quickly establish myself. Moreover, given the opioid epidemic facing this community, I would like to emulate what other State judges have done by expanding less punitive ways to reach non-violent offenders who are afflicted.

Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes, I will uphold the law as written, such being the supreme responsibility of the judiciary. Recently, I worked on a case with Judge Thomas that dealt with a conviction for unlawful photography. The case involved a Sullivan County man who had a predilection for filming clothed women in public without their consent. See State v. David Eric Lambert, No. E2018-02298-CCA-R3-CD, 2020 WL 2027761 (Tenn. Crim. App. Apr. 28, 2020). This man was a serial offender and had also been charged in two other cases. Though the constitutionality of the unlawful photography statute was upheld, the CCA found that the evidence was insufficient to support the Defendant's conviction under the statute in effect at that time. After a review of the legislative history and the statutory term "reasonable expectation of privacy," the CCA reasoned that the victim did not have "an actual, subjective expectation of privacy" and that society was not willing to view any subjective expectation of privacy as reasonable and justifiable under such circumstances. The statute has since been amended to define "reasonable expectation of privacy" and could arguably cover such behavior. Nonetheless, it was my job to draft an opinion for Judge Thomas reversing this conviction under the statute in effect at that time, though I was displeased with the result. The media covered this opinion as supporting a man's right to follow and film a woman in public; however, it is not the judiciary's job to craft the law as it sees fit.
