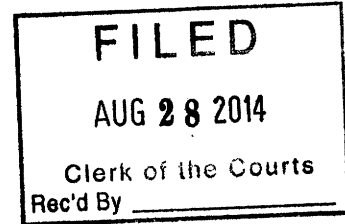

ORDER SETTING CASE FOR TRIAL BEFORE HEARING PANEL
AND SCHEDULING ORDER

A pretrial conference was held on June 18, 2014, in the chambers of Judge Chris Craft acting as Chair of the Board of Judicial Conduct, with Timothy Discenza, disciplinary counsel for the Board and Judge John Donald, *pro se*, participating. A court reporter was waived by all parties, and the following matters were agreed upon by consent:

1. That the above-styled cause was to be set for trial before a duly designated Hearing Panel of the Board in accordance with the provisions of Tenn. Code Ann. § 17-5-308 and § 17-5-301(b) on October 8, 2014, beginning at 10:00 a.m. Central Time in the Supreme Court courtroom in the Shelby County Courthouse, 140 Adams Avenue, Memphis, Tennessee. That date has since been changed by consent to October 1, 2014, at 10:00 a.m., and is so ordered.
2. That any motions to amend the pleadings were to have been filed on or before August 18, 2014.
3. That any additional discovery will have been filed on or before August 15th.
4. That any written responses to discovery shall be filed on or before August 29, 2014, by which date witness lists (including expert witnesses) shall also be exchanged.
5. That any and all depositions shall be completed by September 12th.


6. That trial subpoenas should be issued on or before September 29th. However, that was agreed to in consideration of an agreed upon October 8th trial date. As the trial date has been moved forward one week to October 1st, the parties shall issue subpoenas early enough ensure service.
7. All pretrial motions filed by the parties shall be heard on September 22, 2014 at 10:00 am at the Shelby County Courthouse in the Supreme Court Courtroom, at a public hearing with a court reporter present, said motions to be heard solely by the Chair without the necessity of the Hearing Panel, by agreement of both parties.
8. The Chair shall engage the services of a court reporter for any and all hearings on motions and for the trial.
9. The provisions of this Scheduling Order are subject to amendment by the Chair upon motion for good cause shown, to ensure a fair and impartial trial. All other matters are reserved.


