I have been in the general practice of law with the firm of Phillips and Hale from 1976 to the present. I have also served as the City Attorney for the Town of Rogersville during the same time period. My practice includes appearances before all state courts and federal courts (Eastern District of Tennessee and 6th Circuit.) I have also been involved in the banking profession as secretary and chairman of the board of directors of Tennessee chartered banks.

My practice principally involves business and real estate (30%), banking (25%), municipal law (25%) and domestic relations and estates (20%). I am involved in litigation in each of the areas of practice.

I have represented both plaintiffs and defendants in all types of litigation and individuals and businesses, large and small, in transactional matters. During the first several years of practice I represented criminal defendants at the trial and appellate level. I was counsel for the defendant in *State v. Lakin, 588 S.W.2d 544 (1979 Tenn)*, a case that changed the definition of "open fields" for purposes of a warrantless search.

I have represented litigants at the trial and/or appellate level in tort actions, contract actions, boundary line/real property disputes, governmental/statutory actions and municipal matters. I have represented clients before regulatory agencies including the Environmental Protection Agency, Tennessee Department of Environment and Conservation and the Tennessee and Virginia Departments of Occupational Safety and Health Agencies. I have represented both plaintiffs and defendants before the federal bench in civil rights matters.

I have been general counsel for two banks. I have represented many clients in large and small

transactional matters including the sale and purchase of businesses, drafting and negotiating manufacturing contracts and organizing real estate developments. I have closed hundreds of commercial and residential mortgage transactions.

My law firm, Phillips and Hale, currently consists of three lawyers including my brother, James O. Phillips, III and my son, William E. Phillips, II. The firm was organized in Rogersville in 1916 by my grandfather James O. Phillips who was later joined by my uncle, Winfield B. Hale, Jr., who served on the Tennessee Court of Criminal Appeals and as a Nuremberg War Crimes Tribunal trial judge. Other attorneys in the firm were Winfield B. Hale, III and my father James O. Phillips, Jr. who served as Chancellor for what is now the 3rd Judicial District.

35. What are your reasons for seeking this position? (150 words or less)

I have practiced law for many years, and I believe that I have a breadth of experience that would be beneficial to the administration of justice at the trial level. In addition to experience in purely legal matters I have served and worked in numerous business and social capacities that have led to a better understanding of the nature of social interaction and the origin of disputes and the ability to resolve those disputes in the least abrasive manner.

I also have a sense of duty and obligation to those who have preceded me and those who will follow me in my firm and profession to continue service to the law and to the profession in a manner that will lend respect to both.

36. State any achievements or activities in which you have been involved which demonstrate your commitment to equal justice under the law; include here a discussion of your pro bono service throughout your time as a licensed attorney. (150 words or less)

I was a member of the organizational board of directors of Legal Services of Upper East Tennessee, an organization providing free legal services to indigent clients. I have continued to provide pro bono services to clients throughout my career. My practice has been principally in rural Eastern Tennessee. There are many people desperately in need of legal assistance who have no ability to pay. I feel it is my duty to provide an avenue to justice for those unable to afford the services of an attorney, and I have devoted scores of hours each year to that endeavor.

37. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (*150 words or less*)

I seek the office of Chancellor of the 3rd Judicial District. (Hawkins, Hamblen, Greene and Hancock counties). There is currently one Chancellor, three Circuit Judges who primarily handle civil matters and one Circuit Judge who presides over the Criminal Court. The district is generally rural. The types of cases heard in Chancery Court cover nearly all causes of actions other than those grounded in tort and for unliquidated damages for injuries to property not resulting from a breach of contract. Chancery also has probate jurisdiction. One Circuit Judge is from Hawkins County, and he has announced his retirement effective May1, 2013. One Circuit Judge is from Hamblen County and two from Greene County.

38. Describe your participation in community services or organizations, and what community involvement you intend to have if you are appointed judge? (250 words or less)

I have been currently mostly involved in working with the Heritage Association of Rogersville (RHA) and the Rogersville Presbyterian Church (RPC). RHA has been in existence since the early 70s and has been the driving force behind the preservation of historic structures in Rogersville and the heritage of our area. RHA is the owner of several historic structures that the organization refurbished and saved from destruction including the Hale Springs Inn, an inn built in 1848 where three presidents have lodged. The Inn is now fully operational with an excellent restaurant on site. I have devoted many hours of volunteer legal services to the programs of RHA.

I am actively involved with RPC and its programs. I currently serve as a trustee of the church and have served as a deacon and elder. I have also been a member of the Rogersville Rotary Club and participated in its many community assistance and improvement programs.

I hope to continue my involvement in services to my community within the bounds of judicial propriety.

39. Describe life experiences, personal involvements, or talents that you have that you feel will be of assistance to the Commission in evaluating and understanding your candidacy for this judicial position. (250 words or less)

The primary experience that qualifies me for the judiciary is 37 years of law practice with what I believe is an untarnished reputation. I have zealously represented my clients within the rules of professional conduct while maintaining the respect and friendship of my colleagues. I have represented clients in a wide variety of matters and involving many different causes of action.

My life experiences include military combat which tends to evoke an appreciation for and an ability to cope with stress. My military experience also instilled a work ethic which has served me well in the practice of law and in life generally.

I appreciate and understand the necessity of family relationships as the core to a strong society. Yet I equally understand that there are many who must survive and succeed without the benefit of those relationships.

The ability to interact with people whose perspectives and beliefs differ from one's own and to appreciate those perspectives and beliefs and the conclusions drawn therefrom is an important element to a proper judicial demeanor. I have made an effort in my practice to achieve this ability. The general practice of law and my business experience have provided me with an insight into the practicalities of our society that should be compatible with a proper judicial demeanor.


