My law practice is a varied commercial transactions and business advice practice: real estate development, municipal law, election law and mergers and acquisitions. I provide general corporate advice and strategic planning to businesses and individuals. The mergers and acquisitions and strategic planning advice takes up approximately 70% of my practice. Municipal law (involving my representation of The Industrial Development Board of the City of Knoxville) involves 20% of my practice. The rest of my practice areas take up approximately 10% of my practice. A substantial portion of my time is spent serving as part of the management team for my law firm as the Knoxville Managing Shareholder. As a result of that role, I participate in several strategic initiatives of the firm relating to law practice management.

My 38 year career involved a wide variety of legal services. I initially began my career during the first five years of practice as a municipal bond lawyer involving public finance issues. Throughout my career I've represented major real estate developers and worked on several high profile matters such as development of the Regal Riviera 8 Cinema and Tennessean hotel in downtown Knoxville which involved a combination of public and private financing and collaborative efforts among private and governmental institutions. I have served, and currently serve, as outside counsel for major companies such as Radio Systems Corporation and Tennessee Valley Authority. I have also practiced law internationally in Warsaw, Poland representing Scripps Networks during its ownership of the largest private media company in Poland. I gained valuable experience representing The Industrial Development Board of the City of Knoxville and participated in many of the payment in lieu of tax lease arrangements which spawned much of the downtown Knoxville revitalization. Most of my practice involves offering my clients both corporate and strategic advice related to transactional and litigation matters and assembling teams of lawyers to serve their needs.

I also served from 2004-2014 on Knoxville's Community Development Corporation, including as chairman during the last two years of my ten-year term. This corporation serves the public housing and development needs of the City of Knoxville and allowed me to gain valuable experience with those who live within our public housing communities. In 2020 I developed a program to assist previously incarcerated individuals to restore their voting rights as permitted under Tennessee law. I assisted over a dozen applicants attempting to restore their voting rights in order to participate in the 2020 election. I currently serve on the board of advisors of University of Virginia Center for Politics.

MANAGEMENT AND GOVERNMENT EXPERIENCE

My management philosophy is shaped by my experiences as part of the management of my law firm implementing the firm's strategy, vision, and values. I intend to lead the Attorney General's office based upon these principles. Leaders of great institutions must define for the team a clear strategic vision of the goals to accomplish. Standards of excellence must be established, communicated, and implemented.

The most important lesson I learned is you lead by example to build the trust needed to lead large groups of people. Trust is only established with transparency, honesty, humility, and respect. People will adopt ownership of a strategy if they see a leader who identifies their interests as part of the overall interests of the team.

The Attorney General's office must operate as one firm, rather than siloed interests, to deliver outstanding expertise, service, and value for its clients. I will organize the Attorney General's office as I have in private practice with teams founded upon these standards to accomplish the efficient delivery of superior legal services to the clients of the Attorney General's office. I will identify the skillsets of my team and delegate authority to generate personal ownership in our work. I require team members to address issues only they are best qualified to handle and distribute other work to those with sufficient resources.

I will seek to attract the best and brightest people of great personal character who embrace our shared beliefs of a commitment to the betterment to our communities and profession.

This management philosophy succeeds in the private sector; I see no reason to change this approach as Attorney General.

As the Office Managing Shareholder of our firm's Knoxville office, I work with the Chief Operating Officer, Chairman of the Board, Chief Financial Officer and Board of Directors of our firm to manage our large legal corporation. I directly manage approximately 26 attorneys, paralegals and staff working in the Knoxville office.

My management jobs involve working with our Office Administrator to organize our non-legal staff and oversee the practices of our approximately 17 attorneys. Management of these attorneys primarily involves providing strategic planning advice for the development of their practices as well as helping address issues which arise in their practices. I provide strategic planning advice for the development of our office and assist in the strategic

planning initiatives of our firm. I also handle one of the larger personal practices in our firm and direct different teams consisting of approximately one dozen attorneys to handle work for some of our firm's key clients.

I work closely with the CFO of our law firm on budget matters for the Knoxville office overseeing an approximately \$7 million budget for our office. I review monthly financial statements for our office and our firm and maintain regular contact with the CFO about our financial position. I also review monthly production statistics of all our attorneys including the legal and non-legal hours worked within their practices.

I spend a considerable amount of time recruiting new attorneys to our office and retaining existing lawyers (who are consistently approached by our competitors to leave our firm). I participate with other members of firm management to develop compensation for all our attorneys (most recently serving on a special committee of the Board of Directors to advise on associate attorney compensation).

As chairman of the board of directors of The Episcopal School of Knoxville, I lead the management and strategic planning of this institution which had approximately 300 students during my tenure.

PERSONAL PERSPECTIVE

56. What are your reasons for seeking this position?

The legal system in Tennessee is at a critical, and perhaps existential, juncture in history. The judicial, executive, and legislative branches of our government must work well together for our system of governing to perform and democracy to survive. We must constantly nurture the rule of law and a properly functioning government. Our citizens must have trust in our government institutions, especially our judicial system, if our democracy is to survive.

As legal counsel to the major branches of our state government, the Attorney General must be a strong leader who will set an example for the other branches of government, command respect from his clients (even from those who disagree with him) and promote the effective and efficient delivery of legal services to our citizens. The Attorney General and his team play a crucial role upholding respect for and belief in the rule of law and its role preserving our legal system. This office can serve as a source of accountability among the branches of government to preserve the separation of powers among these branches. I appreciate and enjoy the challenges of leadership and would welcome the opportunity to strengthen our system of justice from the platform of the Attorney General's office.

The Attorney General's office is the in-house legal firm for the State. I enjoy the challenges and opportunities assisting with the management of Baker Donelson and would welcome the chance to implement private legal firm experience in the public sector. My background in law firm management would be tested and utilized as the chief legal officer of the State. The opportunity to lead this team would be a great personal and professional challenge for me, and I am hopeful my leadership skills would serve the State well in this role at this important time in its history.

57. Describe your perception of the primary duties, responsibilities, characteristics, and qualifications for the position of Attorney General and Reporter. Describe which of these may be delegated in whole or in part to subordinates and which may not.

The Attorney General is the leader of a large, in-house law firm for the State of Tennessee whose clients are the branches of our government and the people of our State. My expectation is to set the mission of the AG office to become the most efficient and effective public law firm. The job of the Attorney General is to implement and enforce the laws so long as they comply with the State and Federal Constitutions. First and foremost, the Attorney General must lead by example and set the pace for the rest of his team to achieve the strategic goals of the team.

Like the leader of a private law firm, the Attorney General will develop and implement the strategic plans of the office. The current situation calls for a leader who not only commands

respect from the other branches of government but is also one who can work with holders of different opinions to craft common support for the rule of law and the judicial system.

As Attorney General, one of my important roles is to recruit and retain the best and brightest individuals for the AG's office. My job will be to instill a sense of purpose in our team to deliver value to our clients while adhering to our principles. I will manage the team, recruit its players, craft the strategic plan and implement its mission. It is my job to identify the best use for each individual on our team and make sure those people are in the proper places on the team to fulfil our mission.

While I view my primary job as management of the team, as Attorney General I am responsible for final decisions and the results they create. Where appropriate I will personally engage myself in strategic planning, negotiations, courtroom cases and other opportunities which take advantage of the skills I bring to this position.

58. What is your view of the role of Attorney General and Reporter with respect to the executive branch, the legislative branch, and the judicial branch of state government?

The Attorney General must be a strong leader willing to provide objective legal representation to the applicable branches of government. That legal representation must not vary from enforcing properly passed laws which comply with the Federal and State Constitutions. I owe allegiance to the law and Constitutions even when political forces ignore those fundamental principles of our government. As legal counsel for the State and its branches of government, the Attorney General should be a leader whose advice is valued and respected even when that advice is contrary to the views of those members. The Attorney General must be willing to withstand the winds of opposition and firmly defend the legal values generated by his team. With the inherent battles between the branches of government, the Attorney General can be a great source of accountability, counsel and sometimes a buffer for the other branches. I will work to build trust and respect among the competing branches of government and their confidence in the office of the Attorney General. I view this role similarly to my performance as a private attorney representing my clients by giving them advice they sometimes do not wish to receive but which they appreciate, respect and follow.

59. If selected as Attorney General and Reporter, what is your estimate of the amount of time you will actually appear in court or oral arguments in appellate matters?

I will appear in court on appellate matters when I determine my skills and expertise would most benefit the State. As I perform in private practice, my job is to assemble a team of lawyers and make sure the client receives the best advice and abilities available from our team. My best use is likely developing legal strategy, offering strategic advice and offering management experience for the team.

60. Describe life experiences, personal involvements, or talents that you have that you feel will be of assistance to the Tennessee Supreme Court in evaluating and understanding your candidacy for this position.

My 38-year legal career has offered me many opportunities, challenges and experiences which I will apply as Attorney General. I represented both rich and poor clients and can take on the needs of the clients of the Attorney General's office whether those needs involve the General Assembly or individual citizens. My participation in the management of a law firm composed of more than 600 attorneys, with specific responsibility for the management of all activities of an office of the firm, provided me experiences and insights on how to manage and lead a large group of lawyers and staff. My career fortunately included many intellectually challenging and politically sensitive projects which allowed me to develop the skills and experiences which could assist me as Attorney General. My involvement in Republican political campaigns and election law allowed me to work closely with government leaders and understand the political dynamics which affect our State and its institutions. I will leverage these experiences to develop trust and respect in me, my team, and the legal system of the State. Finally, my personal life experiences provided me both great rewards and major challenges which molded my worldview. While these experiences may not be unique to me, they will assist me as Attorney General.

I understand that the information provided in this application shall be open to inspection upon filing with the Administrative Office of the Courts and that the Administrative Office of the Courts may publicize the names of persons who apply for the position of Attorney General and Reporter.

I knowingly, willingly, and without reservation waive any right or privilege of confidentiality relative to any background checks that may be performed, including, but not limited to, the Tennessee Bureau of Investigation criminal and civil background investigation, including any check of financial or credit information, conducted for the purpose of review by the Tennessee Supreme Court. I also specifically waive any rights or privileges of confidentiality otherwise conferred in relation to checks of the Board of Professional Responsibility, Board of Judicial Conduct, Board of Law Examiners, or similar entity.
