At present, my law practice is primarily focused in the family law area (divorce, custody, adoption, child support, etc.), and I would estimate that area constitutes approximately 75% - 80% of my practice. The remaining 20% -25% of my practice consists of various areas in the general practice of civil law (mainly wills, estates, conservatorships, property disputes, deed preparation, contract preparation, etc.).

My first job after being admitted to the bar was with the State of Tennessee Department of Mental Health and Mental Retardation as the sole staff attorney for Greene Valley Developmental Center here in Greeneville, Tennessee; as such, I was responsible for addressing any legal issues that arose pertaining to the 800-plus residents and 1200-plus employees of that facility at that time.

I resigned from the position at Greene Valley after two years in order to enter the full-time private practice of law with my husband, and we formed the partnership of Woolsey & Woolsey in February, 1982. Early in my private practice, I handled cases in basically every area of the law -- from performing title searches and handling loan closings for the Farmers Home Administration and local realtors, to representing clients in administrative hearings before the Social Security Administration and appeals therefrom, to representing criminal defendants (both appointed and retained), to forming corporations, to taking appointed cases in juvenile court (both as a defense attorney and as a guardian ad litem), to personal injury cases, to workers compensation cases, etc.

After several years of a truly general practice of law, I started honing my practice and "dividing up" some of the general areas of law with my husband. For example, we had discovered that my husband loved the practice of criminal law and I was not quite so enamored of same, so I stopped practicing any criminal defense work.

I have been a litigator during my entire career and have tried hundreds of cases, generally appearing in Court on at least a weekly basis. The vast majority of these trials were before a judge, but I have also had several jury trials in various areas of the law (including criminal, personal injury, will contest, etc.). Some examples are a successful three-day will contest case I tried before a jury in Chancery Court, and a week-long personal injury case that my husband and I successfully tried before a jury. In addition, I have had a few multi-day criminal jury trials; one I particularly remember was a two-day jury trial exactly one week before our first child was born (and which resulted in a not guilty verdict for my client). I have had numerous multi-day trials before a judge, the longest of which lasted five days. I have also been involved in the mediation and settlement of literally thousands of cases throughout my career, and have argued numerous motions and other matters before various courts in this area.

My case load has consisted entirely of my own work, except for a very few cases on which my husband and I have worked together. I have always been fully responsible for all trial preparation and served as the sole attorney on all but a handful of cases. As basically a solo practitioner, I worked very long hours, including many late nights and early mornings. After having children, I got in the habit of working several hours after my children were in bed and before they got up in order not to miss out on their activities while still maintaining a busy private practice.

I have represented civil clients a few times before the appellate courts, but I have to say that very few of my cases have been appealed through the years. Of course, I had several appeals before the Court of Criminal Appeals while I was representing criminal defendants early in my career (particularly pertaining to my appointed cases).

Throughout my career, I have tried cases in all of the civil courts, Circuit and Chancery, throughout the entire upper East Tennessee area.

I do not recall any matters of special note.

I have served as the municipal judge for the towns of Greeneville, Baileyton and Tusculum for several years; these are appointed positions, and I sit as judge over citations issued by officers of the various towns for violations of the city ordinances, including traffic violations.

I do not recall any noteworthy cases over which I have presided as a judge, mediator or arbitrator.

11. Describe generally any experience you have of serving in a fiduciary capacity such as guardian ad litem, conservator, or trustee other than as a lawyer representing clients.

I have served as the power of attorney for my disabled mother from and since the time of my father's death in 2001, and am solely responsible for making arrangements for her care and paying her bills.

Throughout my practice, mainly during the earlier years, I served as guardian ad litem for children through the Juvenile Court system, in addition to being appointed a few times to serve in various positions such as guardian ad litem, trustee or special master in Chancery Court .

I submitted my name for the Chancellor position with the 3rd Judicial District when it was last open in 1996, at which time Judge Frierson was appointed to the position. To the best of my knowledge, this was before or in the early stages of the Judicial Nominating Commission, as there was a lot of confusion as to how the position was going to be filled; we were told several different things, including that it would be added to the ballot of an upcoming election, but it ended up being a special election by delegates from the Republican parties of the four counties in the district. I came in second in the voting at that time.

I learned a valuable lesson at that time, as I had relied on a telephone conversation to announce my representation of the defendant and to reschedule the original hearing date; although there were extenuating circumstances, I did fail to follow up that conversation in writing.

ESSAYS/PERSONAL STATEMENTS

35. What are your reasons for seeking this position? *(150 words or less)*

Being appointed to serve as a Circuit Judge for the 3rd Judicial District would give me the opportunity to give something back to a community that has blessed me with a successful and lucrative private practice for many years now. I feel that I have the experience, knowledge, temperament, work ethic and overall desire to excel as a trial judge, and I would consider it both an honor and a responsibility to so serve. I have always strived to present the legal profession in a positive manner to the public, and I feel this would enhance my ability to do so.

36. State any achievements or activities in which you have been involved which demonstrate your commitment to equal justice under the law; include here a discussion of your pro bono service throughout your time as a licensed attorney. *(150 words or less)*

A firmly held belief of mine is that "to whom much is given, much is expected", and I believe we are ultimately judged by how we serve others, particularly those who are not able to do for themselves or who are overlooked by society in general. As such, throughout my career, when a person has come to me in need of legal services without the funds with which to pay for same, I have always been willing to perform the services either pro bono or at a greatly reduced fee. One particular area that I have focused on is drawing up wills and powers of attorney for elderly persons on fixed incomes; I will do several of these each year at either no cost or for a negligible fee (as I have discovered that many elderly persons do not want to feel that they are taking a "hand-out").

37. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. *(150 words or less)*

I am applying to be appointed to a Circuit Judge position for the 3rd Judicial District, comprised of Greene, Hamblen, Hawkins and Hancock Counties; this position is open due to the upcoming retirement of the Honorable Kindall T. Lawson. The Circuit Court division in this district has four (4) judges, one of whom serves as the criminal judge and hears only criminal matters; the remaining three (3) judges hear domestic and other civil litigation cases, including jury trials.

As I have practiced in this Court for a number of years and have been involved in the litigation of virtually every type of case that is heard in this Court, I would be able to seamlessly transition into this position. In addition, my extensive experience as a municipal judge has allowed me to understand the importance of showing respect at all times to both the lawyers and the members of the public appearing before me, while at the same time applying the law in a fair and evenhanded manner.

38. Describe your participation in community services or organizations, and what community involvement you intend to have if you are appointed judge? *(250 words or less)*

I have always been drawn to working with or on behalf of children, as I feel strongly that our children need more strong, positive adult role models in their lives. Throughout the years, I have served on the Boards of Directors for both our local YMCA and Boys & Girls Club. In addition, I served as the Youth Director at our church for several years, and have taught the high school age Sunday School class for many years.

From the time my daughter was in kindergarten until she made the school teams in middle school and high school, I was the head coach for both basketball and softball teams through our local rec department and YMCA. I was awarded the M.A.D. ("Make A Difference") award in 2001 through the recreation department, which is an award given each year to the coach deemed to have best demonstrated the qualities of having a positive influence and making a difference in the lives of the young people with whom we worked.

I have spoken to several civic groups and organizations through the years regarding various legal issues, and have also been invited to speak to students at local schools on different occasions. If appointed judge, I feel I would be in a more enhanced position to be a positive role model and to make even more of a difference in the lives of those with whom I come in contact, and I would continue to strive to do so.

39. Describe life experiences, personal involvements, or talents that you have that you feel will be of assistance to the Commission in evaluating and understanding your candidacy for this judicial position. *(250 words or less)*

I grew up in West Tennessee, and began working for my physician father at the age of fourteen, on Saturdays and during school breaks. My father put himself through medical school while at the same time supporting a wife and unexpected baby. He taught me from an early age to work hard for what I wanted, and I have lived by that lesson.

I have consistently worked 50 to 60 hours per week, even while raising my children. My son graduated from Middle Tennessee State University in 2008, and my daughter just graduated from Carson-Newman College. Once I had my children, I made their activities a priority and found ways to adjust the timing of my work hours; in addition to other activities that have already been referred to, I served as home room mother for my children throughout their elementary years and also served as chaperone for a majority of their school field trips.

When I undertake a responsibility, from being an officer of an organization to coaching to accepting a church position, I have always made a point of devoting the time necessary to perform those responsibilities to the very best of my ability. I have never been just a "joiner"; if something is worth my time to be a part of, I have usually ended up being the leader at some point. I am not afraid of hard work, and will apply this mindset to a judicial position.

40. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. *(250 words or less)*

I would uphold the law even if I disagreed with the substance of same, as I fully understand the responsibility and obligation of a judge to strictly adhere to the law; it is not the function of a judge to try to impose personal likes or dislikes in a matter or to pursue a personal agenda.

A perfect example of this is a law that I run into quite frequently as a municipal judge. CDL (commercial driver's license) holders are held to a higher standard and are not eligible to attend driving school or to have their tickets reduced in any manner, even when in their private vehicles. I personally do not agree that this should apply when a CDL holder is in his/her private vehicle, as I believe that commercial vehicles (such as a tractor/trailer rig) are inherently much more dangerous than a private, regular vehicle, thus providing justification for the higher standard; in addition, these tickets have a very damaging effect on the driver's ability to maintain employment. It is easy to feel sorry for these drivers, and they are adept at playing on your sympathies, but the law is clear on this issue. Although I know of several judges who ignore the law when a commercial vehicle is not involved, I have always explained to the drivers that they are as aware of the law as I am and that, while I may not agree, I am required to uphold the law.


