## MEMORANDUM OPINION<sup>1</sup>

In this action, the Estate has appealed to this Court the denial of an exception to appellee's claim.

A show cause order was entered in this Court on August 29, 2012, directing counsel

for the appellant to show cause why this appeal should not be dismissed for lack of jurisdiction, based upon the untimely filing of the Notice of Appeal. Counsel for the appellant has failed to respond to the show cause order within the time specified in that order.

An untimely notice of appeal deprives this Court of jurisdiction. *See* Tenn. R. App. P. 4(a). Also see *Cobb v. Beier*, 944 S.W.2d 343, 344 n.2 (Tenn. 1997).

It is therefore Ordered and Adjudged that this appeal be and hereby is dismissed. The costs of the appeal are assessed to the Estate of Mina Rhea Martin.
