## Court Cost General

- Court costs are the expenses of handling a case in court. From filing fees, service fees and various other fees passed by the legislature.
- Fees / Taxes are passed to collect monies for certain projects for the state or county.
- Civil costs are paid up front by the filer. The prevailing party in a lawsuit is usually awarded court costs.
- Criminal / Traffic costs are assessed at the end of case and if not paid at disposition, shall be placed on a payment plan criminal (40-24-105(b)) & traffic (55-50-502(j)(2)). If the payment plan is not followed, this will result in suspension of Driver's License.
- There are a limited number of costs/taxes that can be charge on a juvenile case. In Delinquent and Unruly cases, the juvenile may only be assessed fastitution. Any other cost associated with the case may only be assessed to a parent, guardian or other responsible party.

## Court Cost - Standard vs Optional

Some fees within the statute are standard for all courts; whereas others are optional for counties to pass.

These are based on court type, case type and filing types.

Other standard fees are across many statues within the TCA codes. As noted below:

- Blood Alcohol Test \$55-10-413(f)(1) Standard amount of \$250 but limited to certain case types and only assessed if test given.
- Booking Fee \$40-7-122 Standard Fee, however, can be adopted at various amounts up to \$10.00/case
- CIC Tax \$40-24-107(a)(1)(A) Crimes against Persons \$50.00 (specific case types) CIC Tax \$40-24-107 Crimes against Property \$26.50
- County Expense Fee \$40-24-107 Charged on certain crimes \$5.00
- County Litigation Taxes \$67-1-602 various amounts, however, cannot exceed State Litigation Tax. These can also be broken up for various earmarked projects in the county such as Library Tax, etc.

## **Standard Fees & Taxes (continued)**

- District Attorney Fee (TCADA Fee ) \$40-3-204 \$75.00 charged on all Title 39 Chapter 14 parts 1 and 6.
- District Attorney Fee (Worthless Check) \$40-3-204 varies by amount of check ranging from \$5.00-
- Drug Court Treatment Fund \$16-22-109 \$75.00 on specific charges. Broken into a county drug
  portion \$70.00 + \$5.00 state portion. This amount increases if your county has a Veteran's Court
  to \$13.0.00, with county getting \$70.00 drug portion + \$50.00 veteran portion and increases state
  portion to \$10.00. If no drug court exist in your county the monies turned over to the county shall
  be sent by the Trustee to the state each year.

# **Standard Fees & Taxes (continued)**

- Drug Test Fee §39-17-420(h) \$250.00 on specific charges. Assessed regardless if test is given upon Conviction/Pre Trial or Judicial Diversion
- Electronic Monitoring Fee \$39-13-102(e)(4) and \$39-13-111(c)(7) \$10.00 on specific charges
- Ignition Interlock Fee \$55-10-413(a)(1) and 69-9-219(c)(1)(9) \$40.00 only applies to specific
  charges, charged even if device is not ordered. No clerk commission. An additional one time
  use fee of \$12.00 shall also be charged IF first time for Ignition Interlock
- Jail Fee 8-26-105 Standard Fee, however, can be adopted at various amounts

### **Standard Fees & Taxes (continued)**

- \* Moving Violation \$ 67-4-604(g) \$1.00 charged on all Title 55 Chapter 8 offenses.
- Reckless Fine § 55-10-205(d)(2) \$50.00 on specific charges. In addition to any other fine.
- Restitution \$40-35-304 Amount set by judge. Restitution assessed on/after 1-1-2022 should be paid in full before any other tax or cost \$40-24-105(a)
- Sex Offender Fine § 40-24-108 \$200.00 on specific charges. In addition to any other fine.
- $\bullet \; \mathsf{Sex} \, \mathsf{Offender} \, \mathsf{Surcharge} \, \$ \, \mathsf{39-13-708} \, \mathsf{up} \, \mathsf{to} \, \$ \mathsf{3,000.00} \, \mathsf{on} \, \mathsf{specific} \, \mathsf{charges}. \, \mathsf{Judge} \, \mathsf{assesses}.$

   Criminal (General Sessions & Circuit \$29.50 per convicted charge or by order

  - Chancery & Circuit Civil \$23.75 per case

  - General Sessions Civil \$17.75 per case
     Juvenile is not allowed to charge Litigation Taxes 67-4-604(b)(1)
- TBI (Breath) § 38-6-103(d)(1)(A)(ii) \$17.50 Some counties operate a local BAC instead of
- TBI (Drug) \$38-6-103(d)(1)(A)(i) \$20.00 on specific charges related to Drug Charges

- TBIF (Drag Racing) \$68-55-306 \$25.00 on specific charges related to Drag Racing
- TBIF (Reckless) \$68-55-302 \$30.00 on specific charges related to Reckless Driving
- TBIF (DUI/Revoked/Suspended) §68-55-303 \$15.00 on specific charges related to DUI/Revoked/Suspended charges
- TBIF (Leaving Scene Injury/Death) §68-55-305 \$15.00 on specific charges related to Leaving the Scene of an Accident with Injury and /or Death
- TBIF (Speeding) \$ 68-55-301 \$5.00 charged on all speeding violations greater than 9 miles over speed limit
- Victim Notification Fund Tax § 67-4-602 \$3.00 per convicted charge or by order

## **Optional Fees and Taxes**

There are many optional fees and taxes that must be adopted by the County Legislative Body. Even if adopted, some have standard amounts and some legislation allows the county to adopt the fee at various rates.

- Archives Fee \$10-7-408 Up to \$5.00 per case
- Courthouse Security Tax \$67-4-601(b)(6) Up to \$25.00 per case
- Courthouse Jail Renovation \$67-4-601(b)(1) Up to \$10.00 per case
- General Sessions Judicial Commissioners Education § 67-4-602(k) \$2.00 Only charged in counties with Judicial Commissioners/Magistrates
- General Sessions § 16-15-5006 Local Judge Tax Amount varies greatly across the state from \$6.00 to ~ \$80.00. Set by county legislative body to assist in paying GS Judge salary. Cannot be assessed in Juvenile.

## **Optional Fees and Taxes (continued)**

- Jail Building Tax \$67-4-601(b)(5) Up to \$25.00 per case
- $\bullet \ \, {\it Juvenile Facility Construction \$8-21-402\,\$75.00} \, (specific \, to \, certain \, population \, class)$
- Public Defender Fee §40-14-210 \$12.50 County Legislative Body must pass in most counties, however, it shall be charged in Knox and Shelby Counties
- Victim Assistance § 40-24-109 split \$3.00 Clerk Fee and \$42.00 paid to Trustee or Designated assistance agency
- Victim Offender Mediation Tax \$16-20-106 Needs to be passed by county legislative body and is solely for General Sessions and Juvenile Courts. Various sections of the TCA allows for specific populations to pass.
